Title (mandatory by originator) Updating the SVA Data Catalogue for CP1546	
Description of Problem/Issue (mandatory by originator) <p>CP1546 was approved for implementation on 30 June 2022 at the October SVG meeting (SVG248/08). CP1546 will introduce two new Market Messages (formerly Data Transfer Catalogue (DTC) data flows) for use in Balancing and Settlement Code Procedure (BSCP) 520 ‘Unmetered Supplies’. The two new data flows include:</p> <ul style="list-style-type: none"> • Unmetered Supplies (UMS) Inventory (D0388) – a combined Summary Inventory and Central Management System (CMS) Control File, which is sent from the UMS Operator (UMSO) to a Meter Administrator (MA); and • UMS Response (D0389), which is sent from the MA to the UMSO to either accept or reject a D0388. <p>These flows will be referenced and utilised by the Supplier Volume Allocation Agent (SVAA) through the SVA Data Catalogue (DC) Volume 1 and 2. However, during the assessment of CP1546, the SVA DC Volume 1 and 2 were unintentionally excluded from the impacted documents.</p> <p>As a consequence, the two new data flows were not included in the SVA DC Volume 1 and 2.</p>	
Proposed Solution (mandatory by originator) <p>This CP seeks to update the SVA DC Volume 1 and 2 to include the two new data flows. Additionally, it will include the approved UMS data items for Energy Market Data Specification (EMDS) in the SVA DC Volume 2. These data items include:</p> <ul style="list-style-type: none"> • Charge Code; • CMS Indicator; • CMS Unit Reference; • Effective from Date {UMS}; • Inventory Sequence Number; • Number of Items; • Response Reason Code; • Switch Regime; • UMS Error Code; and • UMS Sub-Meter 	

<p>Justification for Change (mandatory by originator)</p> <p>If this change is not implemented, the SVA DC Volume 1 and 2 will not contain the approved data items (D0388 and D0399) therefore, making it an inaccurate reference document for SVA Parties, after 30 June 2022.</p>
