Title: Inclusion of new LDSO-mastered SMRS data items in the SVA Data Catalogue, the REC EMAR Data Specification and BSCP604	
Description of Problem/Issue (mandatory by originator)	
<p>Approved Change Proposal CP1558 ‘New Registration data items to facilitate MHHS’, which has been approved for implementation in the June 2023 Release of BSC Systems will introduce changes to BSCP501 ‘Supplier Meter Registration Service’ and BSCP515 ‘Licensed Distribution’ to specify additional data items that each Licensed Distribution System Operator (LDSO) will be required to send to the relevant Supplier Meter Registration Agent (SMRA). The Supplier Meter Registration Service (SMRS) will then be required to send these new data items to the Electricity Enquiry Service (‘EES’, formerly known as ‘ECOES’).</p> <p>However, before the EES can publish any new data items, they must first be registered in the Retail Energy Code (REC) Energy Market Asset Repository (EMAR) Data Specification (DS), and the EES software will need to be amended to accommodate the data items. CP1558 did not include any change to the EMAR DS, so EES will not be able to publish the four new data items specified in CP1558 before this CP has been implemented.</p> <p>Also, at the time of approval of CP1558, BSCP604 ‘Error Resolution and Retrospective Manual Adjustments’ was not live, as this document was introduced under P436 ‘Consequential BSC changes for Switching SCR (REC 3.0)’ on 18 July 2022 as part of a Non-Standard BSC Release. Now that BSCP604 is live it will need to include the new data items being introduced by CP1558 to allow for manual correction during the migration/population period which will be coordinated by the MHHS Programme once the new data items are introduced.</p>	
Proposed Solution (mandatory by originator)	
<p>Amend the EMAR DS to include the four new data items specified in CP1558:</p> <ul style="list-style-type: none"> • Associated Import / Export MSID • Connection Type • Connection Type Effective From Date (EFD) • Connection Type Effective To Date (ETD) <p>Amend the SVA Data Catalogue Volume 2 to include these four data items plus one further item which already exist in the EMAR DS:</p> <ul style="list-style-type: none"> • Metered Indicator <p>Amend BSCP604 to allow the LDSO to request Retrospective Manual Adjustment of the six data items specified in CP1558.</p>	

Amend BSCP501 and BSCP515 to align terminology with respect to these six data items, and also remove redundant references to 1998 Trading Arrangements Indicator.
<p>Justification for Change (mandatory by originator)</p> <p>If this change is not implemented, SMRAs will not be able to publish the new data items on the EES, so they will not be available for use by MHHS.</p> <p>BSCP604 requires amendment to allow these new data items to be corrected if necessary by the LDSO.</p>

<p>Estimated Implementation Costs (mandatory by BSCCo)</p> <p>Less than £1k of effort to implement the necessary document changes.</p>
