E.ON	Yes	To support the introduction of the scheme we'd support the recommendation for approval, however we'd refer you to the comments on the drafting and the questions which need answering to support Supplier delivery.
Bulb Energy Ltd	Yes	We agree with the Panel's decision so that the BSCCo is able to facilitate the EPG scheme as Scheme Administrators, reducing the cost to consumers.
Citizens Advice	Yes	We support the recommendation that P446 should be approved because it will facilitate competition (Objective C) and support the efficiency of the balancing and settlement arrangements (Objective D). This will be delivered by increased market stability through consumers increased ability to pay their energy bills, which will ensure that the balancing and settlement arrangements occur with efficiency. However, the reason might be clearer as to support the short-term operation of the energy market. This should perhaps be an additional objective that explicitly reflects scope necessary for future modifications.

E.ON	Yes	<p>14.1 (c) – the start of this sentence doesn't read right, it either needs clarifying on what needs to be saved or the sentence needs to be deleted and starting with 'each party'.</p> <p>14.1 (g) – we are concerned that immediately deleting paragraph 14 upon BSCCo ceasing the role of administrator removes the obligation to participate in the scheme, the data is likely to be required (although legal text might need editing). We would prefer for the scheme paragraph to be made into a sunset clause and deleted once the scheme is no longer required but based on the bank account being empty and fully reconciled.</p>

E.ON	Yes	<p>We are seeking clarification on the following points:</p> <ul style="list-style-type: none">• Can the EPC SoS document be included as part of the legal text annex for visibility and transparency?• The Scheme Administrator is responsible for provision of reporting – how will this look, what data will it contain and who will it be sent to? We'd prefer these requirements to be codified due to the nature of the delivery and to ensure consistency and transparency• For the administration of this service we'd like a rough estimate of what will be shared or how it would be incorporated into current budgeting costs• The mod mentions EAC/AA and CCID however this is not mentioned in the legal text, for transparency we believe this should be incorporated into the legal text, can this be completed?• The solution on invoicing/payment is lacking detail of if this will be included as a line item but our assumption is this will not be the case and it will instead be communicated through the designated reporting only – please confirm our assumption is correct?• For the specific bank account how is interest on the money paid in being accounted for or will it be established in a way where interest will not be an issue?• What is the process to deal with any funds which cannot be passed to Suppliers? And also how will the bank account be closed once the scheme is closed to ensure no funds are remaining?• How will disputes be managed?
