What is the purpose of this Circular?

This circular invites the Balancing and Settlement Code (BSC) Parties and other interested parties to review and provide comments on proposed changes to BSC Configurable Items and the new Configurable Item necessary to implement the Approved Modification <u>P359 Mechanised process for GC/DC declaration</u>.

All BSC Configurable Items amended or introduced for P359 will become effective on 28 February 2019.

Background

Following submission of seasonal Demand Capacity (DC) and Generation Capacity (GC) values, Parties must redeclare estimates of BM Unit Metered Volume(s) for BM Units if they breach or are expected to breach thresholds described in Section K 'Classification and Registration of Metering Systems and BM Units' 3.4.3.

P359 will introduce an automated Central Registration Agent (CRA) process that identifies GC and DC breaches, calculates new estimates of BM Unit Metered Volumes for breaching BM Units and uses these CRA estimates to update breaching BM Units' GC and DCs.

If so approved, the BSC Configurable Items amended for P359 will become effective on 28 February 2019.
