OPEN SESSION – DECISION PAPERS

1. Non-standard BM Unit application from Uskmouth – ISG206/02

1.1 Uskmouth Power Company Ltd (Uskmouth) applied for a non-standard BM Unit for its Uskmouth biofuel power station at Newport.

1.2 The ISG:

- a) **APPROVED** the non-standard BM Unit for the Uskmouth biofuel power station.

2. Metering Dispensation application D/486 – Uskmouth Biodiesel Power Station – ISG206/03

2.1 Simec Power applied for a lifetime Metering Dispensation (D/486) against Code of Practice (CoP) 2 for the location of the Metering Equipment associated with a new Biofuel Park (Uskmouth Biofuel) located on the site of the decommissioned Uskmouth Power Station.

2.2 The ISG:

- a) **APPROVED** Metering Dispensation application D/486 on a lifetime basis.

3. CP1505 'Allowing 'off site' Commissioning of Current Transformers (CTs) preinstalled in cut outs or switchgear at manufacture for use in Low Voltage (LV) installations – ISG206/04

3.1 [CP1505](#) proposed changes to CoP4 that would allow current transformers that are preinstalled in cut outs or switchgear at manufacture to be Commissioned 'off site'.

3.2 The ISG:

4. P350 Methodology for Load Periods and Sample Settlement Periods– ISG206/05

4.1 This paper summarised the proposed methodology for setting Load Periods (LPs) and Sample Settlement Periods (SSPs) to be used in the derivation of Zonal Transmission Loss Factors, as required by the Balancing and Settlement Code (BSC).
