OPEN SESSION – DECISION PAPERS

1. Continuous Acceptance Duration Limit and De Minimis Acceptance Threshold Review 2018 – ISG210/01

The Continuous Acceptance Duration Limit (CADL) and De Minimis Acceptance Threshold (DMAT) parameters were reviewed for 2018. A two week Industry Consultation was proposed.

The ISG:

- a) **NOTED** the analysis presented;
- b) **APPROVED** The consultation questions provided and suggested some rewording;
- c) **COMMENTED** on the analysis presented in the paper that would be presented for Industry Consultation; and
- d) **AGREED** ELEXON returns to the November 2018 ISG meeting and present the responses from the Industry Consultation.

2. CP1508 'Updating standards in CoPs and BSCP601' – ISG210/02

ELEXON proposed to update all current of Codes of Practice (CoPs) and Balancing and Settlement Procedure (BSCP) 601 International Electrotechnical Commission (IEC) and British Standards Institution (BSI) standards, to their latest published equivalent within CoPs 1, 2, 3, 4, 10 and BSCO601. ELEXON also proposed amending current standard prefixes where versions of a standard have been published and approved by the BSI and IEC.

The ISG:

- a) **APPROVED** the amendments and proposed changes; and
- b) **NOTED** that CP1508 will also be presented to the SVG for decision on 30 October 2018.

3. Approval of Configurable Item for November 2018 release – ISG210/03

ELEXON proposed to add an item to the NETA IDD Part 1 spreadsheet.

4. Metering Dispensation D/489 – Cheshire Power Station – ISG210/04

RWE Generation UK applied for a lifetime Metering Dispensation against Code of Practice (CoP) 2, for the Cheshire Power Station.

The ISG:

- a) **APPROVED** the lifetime metering dispensation, subject to demonstration that the required Reactive compensation is within the required accuracy.

5. Metering Dispensation D/490 – Sellindge – ISG210/05

National Grid Interconnectors applied for a lifetime Metering Dispensation against Code of Practice (CoP) 1 for Sellindge.

The ISG:

- a) **APPROVED** the lifetime metering dispensation, subject to the applicant reporting monthly to ELEXON on a rolling six month period the number of Settlement Periods below 100MW.
