Summary This paper invites the Imbalance Settlement Group (ISG) to approve changes to the New Electricity Trading Arrangements (NETA) Interface Definition and Design (IDD) Part 1 spreadsheet for Approved Change Proposal CP1506 as part of the November 2018 Release.

1. Background

- 1.1 Approved Change Proposal [CP1506 'New Interconnector fuel type'](#) will enable the Balancing Mechanism Reporting Agent (BMRA) to receive, store and publish data relating to the forthcoming Nemo Link Interconnector. ELEXON will implement CP1506 on 1 November 2018 as part of the November 2018 Release of BSC Systems.
- 1.2 The Panel approved the amendments to the New Electricity Trading Arrangements (NETA) Interface Definition and Design (IDD) Part 1 document for CP1506 when approving CP1506 at its meeting on 12 July 2018 ([Panel paper 280/09](#)).
- 1.3 The changes to the IDD Part 1 document were sufficient to define the solution to CP1506 to allow industry to carry out an impact assessment on CP1506 but, as part of the implementation of the software changes for CP1506, a change is also required to the IDD Part 1 spreadsheet to add "INTNEM" to the Valid Set for the Fuel Type data item, which will allow the BMRA software to process and publish data relating to the Nemolink Interconnector.
- 1.4 As the ISG is the owner of the IDD Part 1, ELEXON is presenting the amended IDD Part 1 spreadsheet to the ISG for approval, in order to give full effect to Approved Change Proposal CP1506.
