About This Document

This document is the Change Proposal (CP) Assessment Report for CP1510 which ELEXON will present to the Imbalance Settlement Group (ISG) at its meeting on 20 November 2018 and the Supplier Volume Allocation Group (SVG) at its meeting on 4 December 2018. The ISG and SVG will consider the proposed solution and the responses received to the CP Consultation before making a decision on whether to approve CP1510.

- This is the main document. It provides details of the solution, impacts, costs, and proposed implementation approach. It also summarises the ISG and SVG's initial views on the proposed changes and the views of respondents to the CP Consultation.

1 Why Change?

What are the current processes?

The current Market Entry, Market Exit, Balancing Mechanism (BM) Unit registration and Authorised Signatories processes are paper based using numerous forms contained within the Balancing and Settlement Code Procedures (BSCPs). These are based on processes that were developed at New Electricity Trading Arrangements (NETA) go live when the forms were submitted by fax or post. The forms require the same information to be populated over multiple forms, and because of this, the process should be updated to be simpler and more streamlined for Market Participants.

How are the processes changing?

The processes surrounding Market Entry, Market Exit, BM Unit registrations and Authorised Signatories are not being amended. However to ensure that the processes are not viewed by participants and potential participants as restrictive, ELEXON is developing a 'self-service' online platform that will give both participants and central BSC Agents a holistic view of Parties' registration data.

This is a tool, being developed under ELEXON's Foundation Programme project, that will enable greater engagement in the BSC arrangements by Market Participants, but will not be mandated and those wishing to continue using the paper based forms will be able to do so.

How are Authorised Signatories managed?

Like the registration process, Authorised Signatories are appointed and maintained using paper forms, in this case contained in [BSCP38 'Authorisations'](#). Authorised Signatory data can only be amended by an existing Category 'A' Authorised Signatory¹. If multiple people are being authorised then the forms need to be duplicated which can make the process laborious and difficult to manage.

Are there any online forms currently?

Currently Category 'A' Authorised Signatories can access a limited number of online forms via the ELEXON Portal relating to maintaining Authorised Signatory data and submission of some BSC operational data. This functionality is not widely used by Market Participants, and is a digitised version of the paper forms rather than being a more advanced and interactive 'self-service' option.

What is the issue?

The existing process of submitting paper forms for Market Entry, Market Exit, BM Unit registration and Authorised Signatories can be improved to enhance the customer experience. The same information is populated over multiple BSCP forms, which may cause inefficiencies for the customer.



What is the Foundation Programme?

The [Foundation Programme](#) is a project being undertaken by ELEXON to update the BSC Central Systems and create an online platform for Parties to maintain and manage their registration data.



What are Authorised Signatories?

To safeguard the security of BSC Parties and their confidential data, ELEXON will only carry out specific activities on behalf of BSC Parties upon request from persons that have been specified as having the sufficient level of authorisation within the company.

¹ Except for the initial Category A Authorised Signatory, which requires a director's letter.

Over recent years, there has been an increase of new market entrants, which is likely to further increase with the implementation of forthcoming industry changes affecting BSC processes, such as [Modification P344 'Project TERRE implementation into GB market arrangements'](#). The increase in new participants requires the introduction of a more efficient, digitised process for Market Entry, Market Exit, BM Unit registration and Authorised Signatories.

The Participant Management work stream under ELEXON's Foundation Programme is seeking to digitalise the BSCP forms for Market Entry, Market Exit and registrations processes. A configurable Software as a Service (SaaS) based platform for a complete view of Market Participants is being designed and a number of BSCPs need to be updated to allow the new online platform to be used as an alternative to paper forms.

Proposed solution

To simplify the Market Entry, Market Exit, BM Unit registration and Authorised Signatories processes and reduce the reliance on paper forms, CP1510 proposes to amend the processes prescribed in the relevant BSCPs to include the online platform being developed under the Foundation Programme as an approved submission method. The solution will facilitate the implementation of the Participant Management System being developed under the Foundation Programme, which encompasses:

- Moving the existing Central Registration Agent (CRA) functionality to Salesforce and, in doing so, allowing self-service maintenance of Authorised Signatories (other than the initial Category A); and
- Offering an alternative Salesforce permissions-based approach for authorisation levels where the category is relevant to Participant Management and thus allowing the use of system permissions, where they exist, as an alternative to the current approach of storing passwords in the registration system.

The proposed wording of the changes in the BSCPs refers to a 'Self Service Gateway' instead of naming the system that is being developed. This is to ensure the solution implemented under CP1510 is future-proof and that if a different system were subsequently developed; the BSCPs would not be an obstacle to implementing that solution.

What will happen to the existing online forms?

CP1510 seeks only to update the BSCPs to enable the use of the Self-Service Gateway. However, we recognise that following the implementation of the Self-Service Gateway, the online forms available via the ELEXON Portal will likely become redundant as they will have been superseded. ELEXON expects use of the online forms to significantly decrease once the Self-Service Gateway is available, and as such may consider subsequently removing the functionality from the ELEXON Portal at an appropriate time. This will be influenced by the continued usage of the online forms on the ELEXON Portal, which we will internally monitor.

Proposer's rationale

Having a Self-Service Gateway for submission and management of the Market Entry, Market Exit, BM Unit registrations and Authorised Signatories will improve the customer experience by making it more efficient. It will reduce risk of manual error and rework present in the process. Furthermore, it will provide visibility of status and progress in terms of where potential participants are in the registration process. The customer information will be visible to all relevant parties – including ELEXON, service providers and customers.

The Self-Service Gateway will provide guidance in respect to BSC obligations for Market Entry, Market Exit, BM Unit registration and Authorised Signatories processes that must be complied with. The online portal will also support the delivery of [Modification P344 'Project TERRE implementation into GB market arrangements'](#) whereby new types of participants and an increase in new entrants will be accommodated and facilitated in a more effective fashion.



What is Salesforce?

Salesforce is an off the shelf Customer Relationship Management (CRM) solution that ELEXON is customising to meet the BSC requirements. It is built in such a way that future industry changes will easily be incorporated into the solution.

Central costs

The central implementation costs for CP1510 will be approximately £2060 to implement the necessary document changes and ELEXON's internal working practices.

BSC Party & Party Agent impacts and costs

There will be no mandatory impacts or costs for Parties or Party Agents to implement CP1510, as the existing paper forms and processes will remain as a valid submission method. Participants will only need to interact with the Self Service Gateway if they choose to do so.

4 Implementation Approach

Recommended Implementation Date

The proposed Implementation Date for CP1510 is 28 February 2018 as part of the February 2019 Release. This will align with the intended Implementation of the Foundation Programme Release 1 and the implementation of [Modification P344 'Project TERRE implementation into GB market arrangements'](#).

ISG's initial views

CP1510 was presented to the ISG as a verbal update at its meeting on 20 September 2018. ([ISG209](#))

The ISG questioned what testing was being undertaken to ensure the functionality of the new system. ELEXON responded that testing was being completed under its Foundation Programme, including the involvement of potential users from Industry, and noted that this CP seeks only to allow data submissions via such a platform.

The ISG commented that processes such as Market Entry are a one-time occurrence, and questioned whether this warranted a new online platform. ELEXON responded that an improved Market Entry experience formed part of the benefit of the Foundation Programme. From ELEXON's point of view, the updating of CRA systems will make its back office processes more efficient and ensure that they will be able to handle any future changes. From a participant perspective, in addition to Market Entry, this first release will also provide a platform for BM Unit registration and management of Authorised Signatories. It will also provide participants with a holistic view of their CRA registered data.

The ISG questioned whether as part of the implementation of the Foundation Programme, the BM Unit data would be removed from the ELEXON Portal. ELEXON confirmed that this was not the case. The ISG noted that it would be preferable to have an Application Programming Interface (API) so that Market Participants' systems can interface with the Self Service Gateway.

The ISG believed that to realise the full potential of the project, ELEXON would need to encourage participants to move away from the old paper forms.

SVG's initial views

CP1510 was presented to the SVG as a verbal update at its meeting on 2 October 2018. ([SVG212](#)).

The SVG commented that this appeared to be a sensible innovation. It asked how log-in access to the new system would be controlled and ELEXON confirmed that there would be appropriate security restrictions. ELEXON noted that implementation of the actual system is being undertaken outside of the CP. The SVG asked whether the existing CRA email would still be valid. ELEXON responded that existing processes would not change and that the Foundation Programme was seeking to expand the ways in which participants could interact with the BSC Central Systems. In addition, the online forms available on the ELEXON Portal would not be retired under this project.

We received six responses to the CP Consultation. All respondents agreed with the proposed solution, draft redlining and implementation approach for CP1510. No respondents identified any costs they would incur as a result of CP1510. Three respondents commented that they would be impacted by the change, noting that this would be a positive change. One respondent commented that it would like ELEXON to provide guidance on using the new platform to allow a seamless transition for parties that wish to use it. ELEXON has been engaging with industry stakeholders in developing its Self-Service Gateway, and will continue to provide support and guidance to Parties ready for its implementation.

Comments on the proposed redlining

No respondents provided specific comments on the proposed redlining.

7 Recommendations

We invite you to:

- **APPROVE** the proposed changes to BSCP15, BSCP25, BSCP31, BSCP38, BSCP41, BSCP65, BSCP70, BSCP71, BSCP301, CRA Service Description, and CRA User Requirements Specification;
- **APPROVE** CP1510 for implementation on 28 February 2019 as part of the February 2019 Release; and
- **NOTE** that CP1510 will also be presented to the SVG on 4 December 2018 for decision.
