

# ISG212/03 – APPROVAL OF BSC CIS AMENDED FOR P359

**MEETING NAME** ISG 212

**Summary** This paper presents the BSC Configurable Items amended for P359 as part of the February 2019 Release, sets out the process for their development, review and update, and invites the ISG to approve them to become effective as part of the February 2019 Release .

## 1. Background

- 1.1 Approved Modification [P359 'Mechanised process for GC/DC declarations'](#) ('P359') was approved by the Authority on 17 August 2018 for implementation on 28 February 2019, as part of the February 2019 BSC Release. Only the BSC Sections amended to give effect to P359 were presented to the Authority with the P359 Final Modification Report.
- 1.2 BSC Configurable Items (CIs) were not created or amended for P359 during the P359 Assessment Procedure and so were not approved with P359. As a result, the new and amended BSC CIs required to give full effect to P359 have been developed as part of the February 2019 release.
- 1.3 This paper lists the new and amended BSC CIs for P359, describes the review process, and invites the Imbalance Settlement Group (ISG) to approve the amended BSC CIs to become effective on 28 February 2018, the February 2019 Release implementation date.
- 1.4 ISG is invited to note that the new BSC CI, 'Generation Capacity (GC) and Demand Capacity (DC) Estimation Methodology and Challenge Guidance' will be presented to the Panel for approval on 10 January 2018. We will ask the Panel to delegate the authority for this document to the ISG.

## 2. Development and review of BSC CIs amended for P359

- 2.1 ELEXON has developed changes to the following documents for P359 as part of the February 2019 Release:

- 2.2 These amended BSC CIs, with the exception of the NETA IDD Part 2 document were developed and reviewed by ELEXON, and subsequently updated where appropriate, and the versions shown in the table above were issued for industry review via a [Release Circular](#) on 22 November 2018.
- 2.3 We received no review comments from the industry by 17:00 on 6 December 2018, the deadline for responses. However, during the review period, we realised that the CRA-IYYY (now the CRA-I050) which was issued for review as part of the NETA IDD Part 1, should have been included in the NETA IDD Part 2 instead.
- 2.4 We have amended the NETA IDD Part 1 and have created a redlined version of the NETA IDD Part 2 to correct this error. We do not believe that there is any material impact on the industry for this change, as it relates to a dataflow from ELEXON to the CRA.
- 2.5 These documents are now ready for approval by the ISG.

### 3. Approval of BSCP15 by Supplier Volume Allocation Group

- 3.1 BSCP15 is jointly-owned by ISG and the Supplier Volume Allocation Group (SVG), so will be presented to the SVG for approval at its January 2019 meeting. BSCP15 will only be deemed to be approved if both the ISG and SVG have approved it.

### 4. Recommendations

#### 4.1 We invite you to:

- a) **NOTE** the process for the review and approval of the new and amended BSC CIs;
- b) **NOTE** that the new BSC CI will be presented to the Panel for approval in January 2019;
- c) **NOTE** that the Panel will be invited to delegate authority for the new BSC CI to the ISG;
- d) **NOTE** that one new dataflow issued for review as part of the NETA IDD part 1 has been moved into the NETA IDD Part 2;
- e) **APPROVE** the BSC CIs amended for P359 to become effective on 28 February 2019; and
- f) **NOTE** that BSCP15 must also be approved by the SVG.
