Synopsis	This report sets out the headlines and key decisions of the most recent ISG meeting.

OPEN SESSION – DECISION PAPERS

1. Metering Dispensation D/491 – Gascoigne Wood – ISG212/01

- 1.1 E.ON UK has applied for a lifetime Metering Dispensation (D/491) from Code of Practice (CoP) 2. D/491 relates to the Metering Equipment measuring the supplies to a business park connected to Northern Powergrid’s Gascoigne Wood substation. The existing current transformers are not the correct accuracy class and energy measurement is not taking place at the Defined Metering Point (DMP). However, overall accuracy will be maintained within CoP2 limits at the DMP. The ISG was invited to approve Metering Dispensation application D/491 on a lifetime basis.
- 1.2 The ISG:
- a) **APPROVED** Metering Dispensation application D/491 for Gascoigne Wood on a lifetime basis.

2. Metering Dispensation D/492 – Gascoigne Wood Power Station – ISG212/01

- 2.1 Gazprom Marketing & Trading Retail Ltd has applied for a lifetime Metering Dispensation (D/492) from CoP2. D/492 relates to the Metering Equipment measuring the flows to and from a new diesel Generating Plant (Allen Diesels - 20 MVA total capacity) which is connected into the existing switchgear at Northern Powergrid’s Gascoigne Wood substation, via Harworth Estates’ private network. The new Metering Equipment for the Generating Plant is fully compliant with CoP2 apart from being located 10 metres from the Defined Metering Point. The ISG was invited to approve Metering Dispensation application D/492 on a lifetime basis.
- 2.2 The ISG:
- a) **APPROVED** Metering Dispensation application D/492 for Gascoigne Wood Power Station on a lifetime basis.

3. Approval of the configurable items amended for P359 as part of the Feb 19 Release – ISG212/03

- 3.1 ELEXON presented the BSC Configurable Items (CIs) amended for [P359 'Mechanised process for GC/DC declarations'](#) as part of the February 2019 Release. The ISG was invited to approve them to become effective as part of the February 2019 Release.
- 3.2 The ISG:
- a) **NOTED** the process for the review and approval of the new and amended BSC CIs;
 - b) **NOTED** that the new BSC CI will be presented to the Panel for approval in January 2019;

- c) **NOTED** that the Panel will be invited to delegate authority for the new BSC CI to the ISG;
- d) **NOTED** that one new dataflow issued for review as part of the NETA IDD part 1 has been moved into the NETA IDD Part 2;
- e) **APPROVED** the BSC CIs amended for P359 to become effective on 28 February 2019; and
- f) **NOTED** that BSCP15 must also be approved by the Supplier Volume Allocation Group (SVG).
