Summary This paper invites the Imbalance Settlement Group (ISG) to approve changes to

the ISG-owned Balancing and Settlement Code (BSC) Category 2 Configurable Items (CIs) amended for approved Change Proposal CP1517 as part of the

Wider Access and TERRE Standalone Release.

1. Background

- 1.1 Approved Change Proposal <u>CP1517</u> will deliver the amendments to the Balancing and Settlement Code (BSC) Configurable Items (CI) required for go-live of P344 'Project TERRE' functionality that relate specifically to the software changes and so could not be developed and delivered with P344 on 27 February 2019.
- 1.2 ELEXON developed the changes to Category 1 BSC CIs for CP1517 and issued them for Industry review as part of the CP1517 consultation.
- 1.3 The Imbalance Settlement Group (ISG) approved CP1517 and the ISG-owned Category 1 BSC CIs on 20 August 2019 (ISG220/01) and the Supplier Volume Allocation Group (SVG) approved CP1517 and the SVG-owned Category 1 BSC CIs on 3 September 2019 (SVG 223/03). Please refer to the CP1517 Final CP Report for full details.

2. Industry Review of Category 2 BSC CIs

- 2.1 The Wider Access and TERRE Implementation Project developed the changes to the Category 2 BSC CIs for CP1517 and issued them for industry review via a Release Circular on 9 September 2019, with responses due by 20 September 2019.
- 2.2 We received no responses from the industry review.
- 2.3 Details of the changes of the Category 2 BSC CIs amended for CP1517 are available for download from the Wider Access and TERRE Standalone Release page of the ELEXON website.
- 2.4 The ISG-owned Category 2 BSC CIs amended for CP1517 are listed in the table below, and are now ready for approval by the ISG.
