Summary	This paper invites the Imbalance Settlement Group (ISG) to approve changes to the Balancing and Settlement Code (BSC) Category 2 Configurable Item (CIs) amended for approved Change Proposal CP1516 as part of the December 2019 Standalone Release.		

1. Background

- 1.1 Approved Change Proposal <u>CP1516 'New Interconnector Fuel Type Categories: ElecLink & IFA2'</u> will add two new Fuel Types to the Balancing Mechanism Reporting Service (BMRS) website for two new Interconnectors that are scheduled to go-live in 2020; 'INTELEC' for the ElecLink Interconnector and 'INTIFA2' for the IFA2 Interconnector. ELEXON will implement CP1516 on 18 December 2019 as part of the December 2019 Standalone Release.
- 1.2 As the ISG is the owner of the NETA IDD Part 1 spreadsheet, ELEXON is presenting the amended IDD Part 1 spreadsheet to the ISG for approval, in order to give full effect to the Approved Change Proposal CP1516.

2. Industry Review of Category 2 BSC CIs

- 2.1 We published the amended NETA IDD Part 1 spreadsheet for CP1516 on the December 2019 Standalone 2019 Release webpage and we invited the industry to review it on 22 October 2019 with comments to be returned by 4 November 2019 via a <u>Release Circular</u>.
- 2.2 We received no comments following the industry review.
- 2.3 The amended NETA IDD Part 1 spreadsheet is now ready for approval by the ISG.
