1. Changes required for the November 2021 Release

- 1.1 This paper invites the ISG to approve changes to BSC Configurable Items that have been amended for:
 - P399 'Making the identity of Balancing Service providers visible in the Balancing Services Adjustment Data'.
- 1.2 P399 will introduce four new items as Balancing Services Adjustment Data (and these new fields will be added to the existing BSAD file):
 - BSAD Party ID;
 - BSAD Asset ID;
 - Service type; and
 - Tendered status
- 1.3 P399 will also amend sub flows 1 and 2 of the Settlement Administration Agent (SAA) I014 file (Settlement Report) and the BMRA I014/SAA-I026 file to include the additional data items.
- 1.4 P399 was approved by Ofgem on 18 May 2021 for implementation on 4 November 2021, as part of the November 2021 BSC Release.

2. Industry Review

- 2.1 We published the amended Configurable Items on 16 June 2021 and invited industry comments via a Release Circular by 30 June 2021.
- 2.2 No comments were received from the industry review.
- 2.3 Following a final internal quality review after the closure of the review period, the Field Type was populated for each data item being introduced by P399 in table 4.12.4.1 'Field Type Index by Data Type' of the NETA IDD Part 1 document.
