#### Why change?

The Settlement Administration Agent (SAA) BSC System can currently access a database shared with the Central Registration Agent (CRA) BSC System and Central Data Collection Agent (CDCA) BSC System. However, the SAA BSC System will be migrated to a new cloud platform by February 2023 and will no longer have access to this shared database.

#### Solution

The proposed solution for this CP is to amend the NETA Interface Definition and Design (IDD) documentation to reflect the future state of the interactions between the SAA System and the CRA and CDCA Systems.

#### Impacts and costs

We do not anticipate that this CP will impact any BSC Party or Party Agent.

This CP is a document only change, with no central system changes required. Therefore, the central implementation costs for this CP will be less than £1,000 to implement the relevant document changes.

# Implementation

This CP is recommended for implementation on 23 February 2023 as part of the standard February 2023 Release, this is so that it aligns with the new SAA system going live.

# What is the issue?

The SAA BSC System can currently access a database shared with the CRA BSC System and CDCA BSC System. SAA BSC System will be migrated to a new cloud platform by February 2023 and will no longer have access to this shared database, so the IDD documentation should be updated to reflect the future state of the interactions between these internal BSC Systems.

# Background

There is a SAA-CRA interface ('BM Unit Period Metered Volume') which was not documented in the IDD Part 2. As the shared database is no longer an option for CRA BSC System to get the data that it requires from the SAA BSC System, a new physical SAA-CRA data interface for 'BM Unit Period Metered Volume' will be implemented as part of the SAA migration, which should be defined in the IDD Part 2 'Interfaces to Other Service Providers' document and spreadsheet.

There are several CDCA and CRA BSC Systems interfaces with SAA BSC System that are documented in the IDD part 2 spreadsheet but in the IDD Part 2 word document have the mechanism as shared database:

- CDCA-I027 / SAA-I004 ('Aggregated Interconnector Meter Flow Volumes')
- CDCA-I028 / SAA-I004 ('Aggregated BM Unit Meter Volumes')
- CDCA-I036 / SAA-I004 ('GSP Group Take to SAA')
- CDCA-I068 / SAA-I044 ('Aggregated BM Unit Disconnection Volumes')
- CRA-I013 / SAA-I001 ('Issue Authentication Report')
- CRA-I015 / SAA-I001 ('BM Unit and Energy Account Registration Data')
- CRA-I017 / SAA-I002 ('Credit Assessment Export Capability')
- SAA-I043 / CDCA-I066 ('Demand Control Instructions to CDCA')

The IDD Part 1 document also has a reference to the shared database in mechanism for the SAA-I017 SAA data exception report that will no longer exist.

# **Proposed solution**

1) Amend the "Internal" tab of the IDD Part 2 spreadsheet to include the 'BM Unit Period Metered Volume' interface as defined below:

- Amend the "Groups" Tabs in the IDD part 1 and IDD part 2 spreadsheets to include the new 'Settlement BM Unit Meter Volume' and 'BM Unit Period Metered Volume' Groups
- Amend the "Items" Tabs in the IDD part 1 and IDD part 2 spreadsheets to include the new 'BM Unit Period Metered Volume' Data Item and allocate a "N0xxx" number to it
- 4) Update the IDD part 2 document to include the new interface.
- 5) Amend the IDD Part 2 document to specify the mechanism as 'Electronic data file transfer' for the interfaces below:
  - CDCA-I027 / SAA-I004 ('Aggregated Interconnector Meter Flow Volumes')
  - CDCA-I028 / SAA-I004 ('Aggregated BM Unit Meter Volumes')
  - CDCA-I036 / SAA-I004 ('GSP Group Take to SAA')
  - CDCA-I068 / SAA-I044 ('Aggregated BM Unit Disconnection Volumes')
- 6) Amend the IDD Part 2 document to specify the mechanism as 'Automated interface' and remove other references to shared database for the interfaces below:
  - CRA-I013 / SAA-I001 ('Issue Authentication Report')
  - CRA-I015 / SAA-I001 ('BM Unit and Energy Account Registration Data')
  - CRA-I017 / SAA-I002 ('Credit Assessment Export Capability')
- 7) Amend the IDD Part 2 document to remove reference to a shared database for SAA-I043 / CDCA-I066 Demand Control Instructions to CDCA and replace the mechanism with Manual
- Amend the IDD Part 1 document to remove reference to a shared database for SAA-I017 SAA Data Exception Report

**Proposer's rationale** 

This CP is required so that the IDD reflects the current state of the systems and the new interface is documented formally and transparently.
