

Approval of Configurable Item changes for the November 2023 BSC Release

Summary	This paper invites the SVG and ISG to approve the changes to BSC Configurable Items as part of the November 2023 Release.		

1. What is the purpose of this paper?

- 1.1 This paper invites the ISG and SVG to approve the changes to the BSC Configurable Items (CIs) for one Approved Modification and one Approved Change Proposal as part of the November 2023 BSC Release:
 - [P395](#)¹ 'Aligning BSC Reporting with EMR Regulations – an enduring solution'.
 - [CP1576](#)² 'New Interconnector Fuel Type Category: Viking Link'
- 1.2 Ofgem approved P395 on 6 October 2022 for implementation on 2 November 2023. P395 proposes to amend BSC systems and processes so that the SAA-I042 'BM Unit Gross Demand Report' only includes electricity 'supplied' to premises by licensed Suppliers, and therefore excludes electricity imported by Generators operated by a licensee for generation activities (i.e. those activities authorised by their generation licence to carry on).
- 1.3 The BSC Panel approved CP1576 on 8 June 2023 for implementation on 2 November 2023 as part of the standard November 2023 BSC Release. Changes are needed to the Balancing Mechanism Reporting Service (BMRS) to ensure data relating to the new Viking Link Interconnector is provided to market participants alongside existing data relating to Settlement arrangements in the Great Britain (GB) electricity market.
- 1.4 The draft redlining for the changes to the CIs are included in Attachment A of this paper.

2. Industry Review

- 2.1 We published the changes to the CIs for P395 and CP1576 for industry review between 1 August 2023 and 15 August 2023 (10 Working Days). We received no responses relating to the documents from the industry review.
- 2.2 The versions of the CIs amended for P395 and CP1576 are now presented to the SVG and ISG for approval.

3. Configurable Items for approval

- 3.1 Details of the changes for P395 and CP1576 can be found in attachments A to this paper.
- 3.2 Table 1 lists the documents amended by P395 and CP1576 that Elexon seeks approval for.
