#### 1. Quarterly Performance Assurance Report (QPAR) - PAB222/12

- 1.1 ELEXON presented a Quarterly Performance Assurance Report (QPAR) to the PAB, summarising key activities undertaken within the Performance Assurance Framework during Q1 of the 2019/20 Performance Assurance Operating Period.
- 1.2 The PAB:
- a) **AGREED** the priority of planned TAPAP investigations; and
  - b) **APPROVED** the Q1 QPAR for publication.

#### 2. TAA Annual report recommendations - PAB222/13
