Synopsis	This report set out the headlines and key decisions of the most recent meeting of the Performance Assurance Board (PAB229b).

## **CLOSED SESSION**

## 1. A Supplier's NHH Risk 7/8 Escalation – (PAB229/10)

- 1.1 The Supplier returned after the PAB agreed in September 2019 to allow the Supplier more time to present a more robust and complete plan. Representatives from the Supplier presented an updated EFR plan.
- 1.2 The PAB:
  - a) NOTED the Supplier's update on its Risk 7 and 8 performance;
  - b) COMMENTED on the Supplier's update and the updated Risk 7 and 8 EFR plan;
  - c) **DETERMINED** the Supplier's milestones would be monitored and that escalation to the BSC Panel could be considered if it missed any of its milestones; and
  - d) **ACCEPTED** the Supplier's June and October's milestones for the NHH Risk 7 and 8, and requested a further update to be provided at the October PAB meeting.

### 2. A Supplier's NHH Risk 7/8 Escalation – (PAB229/11)

- 2.1 A Supplier had been invited to attend the February PAB meeting following its failure to meet its NHH obligations under Risk 7 and 8. Representatives from the Supplier attended the meeting to present an updated EFR plan.
- 2.2 The PAB:

  - b) **COMMENTED** on the Supplier's update and its updated EFR plan;
  - c) **DETERMINED** any further actions for the Supplier; and
  - d) ACCEPTED the NHH Risk 7 and 8 EFR plan.
