

# PAB232/08 – APPROVAL OF THE DOCUMENT CHANGES FOR P404 AS PART OF THE JUNE 2020 RELEASE

**Summary** This paper invites the Performance Assurance Board (PAB) to approve changes to various Code Subsidiary Documents following the approval of Modification P404 as part of the June 2020 Release.

## 1. Background

- 1.1 The Qualification and re-Qualification techniques are preventative techniques designed to ensure that new entrants and incumbents going through significant changes have developed their systems and processes to such a standard as they will not introduce risk to Settlement when they go live.
- 1.2 The questions and guidance that support the Qualification and re-Qualifications are contained in Appendices 1, 2 and 3 to [BSCP537 'Qualification Process for SVA Parties, SVA Party Agents and CVA Meter Operators'](#).
- 1.3 ELEXON's PAF Review workstream presented a report with recommendations to the Performance Assurance Board (PAB) at its meeting on 26 September 2019 ([PAB224/11](#)), and the PAB endorsed the recommendations. Amongst these recommendations was that Appendices 1 (Self-Assessment Document (SAD)), 2 and 3 be removed from the BSCP and placed in its own Category 3 Configurable Item.
- 1.4 As the SAD and its associated documents are currently appendices to [BSCP537 'Qualification Process for SVA Parties, SVA Party Agents and CVA Meter Operators'](#), any changes require a BSC Change Proposal (CP). This can make the process of amending the SAD more onerous and limit the Performance Assurance Board's (PAB's) ability to ensure that it aligns with emerging risks identified by the Risk Evaluation Register (RER), Risk Operating Plan (ROP) and PAB Strategy.
- 1.5 The BSC Panel determined that P404 was a Self-Governance Modification and should be approved at its meeting on 09 April 2020 ([BSC Panel 301](#)). In accordance with BSC Section F6.4, Parties had until 1 May 2020 to appeal the Panel's determination. No appeals were notified and so the Panel's decision is final.
- 1.6 As the PAB is listed as one of the responsible committees for the BSCP537, ELEXON is presenting the amendments to these documents to the PAB for approval.
