- 1.1 This paper invited the PAB to Qualify Omni Energy Limited as a Half Hourly Supplier using the 'OMNI' MPID.
- 1.2 The PAB:
 - a) **APPROVED** Omni Energy Limited's application for Qualification for the role of Half Hourly Supplier using the 'OMNI' MPID.
 - b) **DETERMINED** that Omni Energy Limited complete a Disaster Recovery plan within three months of go-live and provide supporting evidence to ELEXON when complete.
