

## Approval of Configurable Item changes for the June 2022 BSC Release

Summary **This paper invites the PAB to approve the changes to BSC Configurable Items as part of the June 2022 BSC Release**

### 1. Changes required for the June 2022 BSC Release

- 1.1 This paper invites the PAB to approve changes to BSC Configurable Items that have been amended for:
- [P375 'Settlement of Secondary BM Units using metering behind the site Boundary Point'](#)
- 1.2 P375 was approved by the Authority on 24 February 2021 for implementation on 30 June 2022.
- 1.3 As the PAB is responsible for the Self Assessment Document (SAD), Elexon is presenting the amendments to this document to the PAB for approval.

### 2. What changes are being made?

- 2.1 Amendments to the SAD were approved on 9 September 2021 ([318/06](#)) under P375. However, during the assessment of [P430 'Extension of P375 to include Suppliers'](#) some improvements were identified. The SAD has been amended to replicate relevant Virtual Lead Party (VLP) questions from Section 19 (VLP) in Section 19A (Asset Metering Virtual Lead Party (AMVLP)), so that parties wishing to become AMVLPs need only complete Section 19A, rather than both. This retains required assurance that a party can operate as an AMVLP whilst removing unnecessary duplication of effort.
- 2.2 This amendment was sent to the members of the P375 Industry Expert Group (IEG) for comment. One member replied, expressing support.
- 2.3 As the changes to the SAD are material, rather than housekeeping, the changes are being progressed under P375.

### 3. Industry Review

- 3.1 We published the amended Configurable Items on 12 May 2022 and invited the industry to review via a Release Circular with any comments requested by 25 May 2022. We received no comments following the industry review.
- 3.2 The amended document is now ready for approval by the PAB.

### 4. Configurable Items for approval

- 4.1 Details of the changes can be found in Attachment A to this paper.
- 4.2 Table 1 lists the documents amended by P375 that require approval by the PAB:

## 5. Approval Ex-Committee

- 5.1 We are seeking approval ex-committee to ensure that final documents can be prepared prior to implementation on 30 June 2022.
- 5.2 The timing of the Release Circular meant that approval could not be requested at May's PAB Meeting.

- 6.1 We invite the PAB to:
  - a) **APPROVE** the amendments to the document listed in Table 1, as detailed in Attachment A, to be implemented on 30 June 2022 as part of the June 2022 BSC Release.
