Prioritising the PAF Balancing and Settlement Code (BSC) and BSC Procedure changes required for MHHS

Summary This paper sets out the Balancing and Settlement Code (BSC) Performance Assurance areas that require review prior to the Market Half Hourly Settlement (MHHS) implementation, and the potential design and Code Changes in order of prioritisation.

1. Introduction

- 1.1 The MHHS Programme (MHHSP) introduces a new Target Operating Model (TOM) along with new industry roles, obligations and systems to enable market wide Half Hourly Settlement.
- 1.2 The MHHSP did not include Performance Assurance changes required for MHHS as part of the design work it has undertaken, which was initially limited to design of the new TOM.
- 1.3 Therefore, Elexon has agreed with the MHHSP that it will consider the Performance Assurance changes required. A Performance Assurance Working Group (PAWG) an open group of industry participants- has been set up to work with Elexon to consider the changes required. Recommendations from this group will be approved by the PAB.
- 1.4 There is an opportunity for these changes to be included in the "Consequential Change" Code drafting phase in the MHHSP plan, approved by the MHHS Cross Code Advisory Group (CCAG) and by Ofgem. The draft plan released for the round three re-plan consultation currently sets any changes being required into the MHHSP by 1 August 2023 to be approved through this route.
- 1.5 This is the most desirable route to make changes, as it ensures that the requirements are in place for MHHS migration, and that the MHHSP has a clear view of all the MHHS related changes.
- 1.6 However, due to the number of Performance Assurance techniques it is unlikely that all areas will be covered in these short timescales. For the Performance Assurance areas, the work would need to encompass the review, design, as well as Code drafting within that time. Modifications in some of these areas in the past have taken a long time to work through the process.
- 1.7 Elexon will therefore raise Modifications or Change Proposals under the Business as Usual process for any areas that are not sufficiently completed by 1 August 2023.
- 1.8 Elexon will continue to work through the areas in a prioritisation order based on:
 - The expected impact of MHHS on the area
 - The volume of change expected
 - Whether the change is required for the start of migration
 - Expected level of debate/variation of views
 - Expected impacts on industry
 - System development requirements expected
- 1.9 Elexon has set out the prioritised list below for PAB consideration and approval.
