- 1.2 The PAB:
 - a) APPROVED Levelise Limited's application for Qualification for the role of Virtual Lead Party (VLP);
 - b) APPROVED Renantis Energy Trading Srl, UK Branch's application for the role of Half Hourly (HH) Supplier;
 - c) **APPROVED** Utility Assets Limited's application for the role of Licensed Distribution System Operator (LDSO), Unmetered Supplies Operator (UMSO) and Supplier Meter Registration Agent; and
 - d) **DETERMINED** that Levelise Limited, Renantis Energy Trading Srl, UK Branch and Utility Assets Limited complete a Disaster Recovery plan within six months of go-live and provide supporting evidence to Elexon when completed.

- g) AGREED that Error Failure Resolution (EFR) should be turned on for a BSC Party in relation to Non Half Hourly (NHH) and Domestic HH (Measurement Class F) performance, including failure to meet the Large Estimated Annual Consumption / Annualises Advance (EAC/AA) Performance Threshold for three consecutive months, and a letter is written to confirm this;
