Synopsis	This report sets out the headlines and key decisions taken at the most recent PAB meeting.		

#### **Part I: Confidential Session**

- 1.1 BSC Party Error and Failure Resolution (EFR) Escalation for Non-Half Hourly (NHH) Settlement Performance (PAB276/01)
- 1.2 Elexon invited the PAB to note BSC Party's Settlement Performance update, approve BSC Party's new milestones, and determine any next steps.
- 1.3 The PAB:
  - a) NOTED BSC Party's NHH Settlement Performance update;
  - b) APPROVED the milestones for February and March; and
  - c) **DETERMINED** that the BSC Party should return to the PAB in March with a revised EFR plan demonstrating the route to returning to a compliant position.

## Part II: Public Session

- 2. Qualification of non-Unmetered Supplies capable Suppliers (PAB276/02)
- 2.1 Elexon sought the PAB's approval for non-UMS Capable Suppliers to be exempt from Qualification for Unmetered Supplies processes.
- 2.2 The PAB:
  - a) **APPROVED** the exemption of Qualification for non-UMS capable Suppliers subject to taking forward specific actions to:
  - i include a change to the BSC to support this as part of the MHHSP Consequential Code drafting; and
  - ii progress a change with Retail Energy Code (REC) to look to make a Central Switching Service (CSS) change to automate a prevention to switching.
- 3. Proposed Performance Assurance Framework (PAF) Changes for Market-wide Half Hourly Settlement (MHHS): Supplier Charges and Performance Standards (PAB276/03)
- 3.1 Elexon invited the PAB to endorse PAF changes for MHHS.
- 3.2 The PAB:

- 4. Risk Operating Plan 2024/25 (PAB276/04)
- 4.1 Elexon invited the PAB to approve the Risk Operating Plan (ROP) for 2023/24.
- 4.2 The PAB:
  - a) AGREED that the draft ROP 2024/25 be issued to Market Participants for comment.

  - g) AGREED that a BSC Party will be escalated to the PAB for NHH Settlement Performance if it fails to return to Compliance by June 2024, irrespective of its performance against other milestones;
  - h) **AGREED** that EFR should be turned on for a BSC Party in relation to Non Half Hourly Measurement Class A and Half Hourly Measurement Class F performance and a letter is written to confirm this;
  - i) AGREED that EFR should be turned off for a BSC Party in relation to Half Hourly Measurement Class C and Half Hourly Measurement Classes E&G performance and letters are written to confirm this; and
  - j) AGREED that EFR should be turned off for a BSC Party in relation to addressing erroneously large EACs and AAs and that a letter is written to confirm this.
- 6. Qualification Report for January 2024 (PAB276/06)
- 6.1 Elexon invited the PAB to Qualify one Qualification application for January 2024.
- 6.2 The PAB:
  - a) APPROVED Squire Energy Metering Limited's application for Qualification for the role of Licensed
     Distribution System Operator (LDSO), Supplier Meter Registration Agent (SMRA) and Unmetered Supplies
     Operator (UMSO) using the MPID: STRK; and

b) **DETERMINED** that Squire Energy Metering Limited complete a Disaster Recovery plan within six months of go-live and provide supporting evidence to Elexon when completed.

## 7. BSCP128 Non-Compliance (PAB276/07)

- 7.1 Elexon sought the PAB's approval to deploy the Error and Failure Resolution (EFR) Performance Assurance Technique (PAT) to monitor a BSC Party's progress against this non-compliance.
- 7.2 The PAB:
  - a) **AGREED** that EFR should be turned on for the BSC Party in relation to its inability to recalculate Generic LLFs in compliance with BSCP128 with and a letter is written to confirm this.

### 8. Supplier Charges October 2023 (PAB276/08)

- 8.1 Elexon invited the PAB to approve the Supplier Charges for the October 2023 reporting period.
- 8.2 The PAB:
  - a) APPROVED the net positions set out in the Payment Instructions for October 2023 (Attachment A); and
  - b) **AUTHORISED** that the Supplier Charges Reports for October 2023 are published, which Elexon will send to Trading Parties.
