

## DRAFT LEGAL TEXT FOR PROPOSED MODIFICATION P369

### SECTION C: BSCCO AND ITS SUBSIDIARIES

*Amend section 2.2.4 as follows:*

2.2.4 Modification Proposal P369 and any modifications to Code Subsidiary Documents or any other document maintained under the Code made pursuant to Modification Proposal P369 shall take effect from 00:00 hours on 1 April 2019.

### SECTION X: DEFINITIONS AND INTERPRETATION

#### ANNEX X-1: GENERAL GLOSSARY (V82.0)

*Amend the following definitions as follows:*

"**De Minimis Acceptance Threshold**": has the meaning given to that term in Section T1.78.1;

"**Equivalent Meter**": means, in relation to an Unmetered Supply, the hardware and software that is used to calculate the half hourly consumption of electricity associated with such Unmetered Supply, which hardware and software meets the specification therefore set out in BSCP520;

"**Transmission Company**": ~~means National Grid Electricity Transmission plc, registered number 02366977, and any reference to "NGC" in the Code or any Code Subsidiary Document shall have the same meaning;~~ means National Grid Electricity System Operator Limited, registered number 11014226, as the holder of the Transmission Licence in relation to which Section C (system operator standard conditions) of the standard Transmission Licence conditions applies and any reference to "NGESO", "National Grid Company" or "NGC" in the Code or any Code Subsidiary Document shall have the same meaning;

"**Transmission Licence**": ~~means the licence granted to the Transmission Company pursuant to section 6(1)(b) of the Electricity Act 1989, as modified from time to time;~~ means a licence granted or treated as granted under section 6(1) (b) of the Act;
