Summary This paper gives a list of proposed dates for the BSC Panel meetings in 2019 and asks for Panel approval of those dates.

1. Background

- 1.1 The Balancing and Settlement Code (BSC) sets out that the BSC Panel is required to meet at regular intervals, at least once a month, currently arranged to occur on the second Thursday of every calendar month. The meetings take place at ELEXON's offices, 4th Floor, 350 Euston Road, NW1 3AW.
- 1.2 The monthly BSC Panel Meetings are scheduled a year in advance. The BSC states that the Panel Secretary will convene Panel meetings by giving notice to each BSC Panel Member not less than five days (not business days) before the date of the meeting (BSC Section B4.1.5).
