Synopsis This report sets out the headlines and key decisions of the most recent meeting of the Trading Disputes Committee.

DECISION PAPERS

1. Trading Dispute DA926– 245/01

1.1 A Supplier raised a Trading Dispute following the discovery of a Meter Current Transformer (CT) ratio mismatch. The Meter was programmed to 100/5A while one of the CTs was incorrectly set to 200/5A. This caused consumption to be over-recorded by around 50%.

1.2 The TDC:

- a) **AGREED** the end date of 24 July 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

2. Trading Dispute DA940 – 245/02

2.1 The consumption data for a Half Hourly (HH) site was overstated in Settlement due to an error in the Meter Technical Details (MTDs). ELEXON considers Trading Dispute DA940 valid against all three criteria for a Trading Dispute.

2.2 The TDC:

- a) **AGREED** the end date of 23 July 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

3. Trading Dispute DA922 – 245/05

3.1 Incorrect consumption data was entered into Settlement for a vacant site due to inaccurate Meter Read History (MRH) provided by previous Supplier and incorrect customer readings. In order to rectify this problem, a Dummy Meter Exchange (DMX) was then performed, but also actioned incorrectly. ELEXON considers Trading Dispute DA922 valid against all three criteria for a Trading Dispute.

3.2 The TDC:

- a) **AGREED** the end date of 31 May 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **AGREED** that the materiality exceeds £3,000;
- d) **AGREED** that a Settlement Error has occurred;
- e) **UPHELD** the Trading Dispute; and
- f) **AGREED** means of rectification through the Post-Final Settlement Run.

4. Trading Dispute DA936– 245/06

4.1 An erroneous Annualised Advance (AA) was entered into Settlement for a Non Half Hourly (NHH) Metering System. This was due to transposed Meter readings creating an incorrect D0086 to be issued. ELEXON considers the Trading Dispute valid against the three Trading Disputes criteria subject to the Trading Dispute Committee (TDC) granting exceptional circumstances.

4.2 The TDC:

- a) **AGREED** the end date of 1 June 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

5. Trading Dispute DA938– 245/07

5.1 The Supplier was informed of an incorrect wiring of the Current Transformer (CT) at a Half Hourly (HH) site. Meter Operator Agent (MOA) corrected the CT wiring and Half Hourly Data Collector (HHDC) corrected Half Hourly (HH) data back to RF on the transposed Import and Export HH data.

5.2 The TDC:

- a) **AGREED** the end date of 23 July 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and

- g) **AGREED** means of rectification through the normal and Post-Final Settlement Runs.

INFORMATION PAPERS

6. Overview of Open Disputes – 245/08

- 6.1 The TDC was provided with an overview of the Trading Disputes currently open and those awaiting rectification. Of the Trading Disputes currently open, the TDC was provided with details of those regarded as long outstanding or presenting a significant impact on Settlement.
- 6.2 The TDC:
 - a) **NOTED** the Trading Disputes currently awaiting rectification and open Trading Disputes; and
 - b) **NOTED** the long outstanding Trading Disputes

7. EAC AA Market and GSP Group Level SEAE – 245/09

- 7.1 The Trading Disputes Committee (TDC) was provided with information to address the issue of Erroneous Large Estimated Annual Consumptions (EACs) / Annualised Advances (AAs) in Settlement.
- 7.2 The TDC:
 - a) **NOTED** that the current levels of error within the SEAE Graphs and further analysis do not meet the Entry Criteria for a Trading Dispute; and
 - b) **NOTED** the content of the paper and attachment.
