Half Hourly (HH) Supplier SR0081 Escalation – PAB215/04

- 1.1 A HH Supplier was escalated to the Performance Assurance Board (PAB) for under-performance against SR0081. The HH Supplier outlined its updated Error Failure Resolution (EFR) plan and invited the PAB to approve it.
 - a) **NOTED** the HH Supplier's update on its SR0081 performance;
 - b) **COMMENTED** on the HH Supplier's update and updated SR0081 EFR plan; and
 - c) **DETERMINED** further actions for the HH Supplier, accepted and baselined the SR0081 EFR plan.

2. Business Unit Settlement Risk Rating (BUSRR) Report – PAB215/01
