# **Draft Modification Report**

# P387 'Allowing email communications for the BSC Panel Elections process'

This Modification Proposal aims to amend the Balancing and Settlement Code (BSC) Panel Elections process to allow communications between parties via email as well as other methods to be approved by the BSC Panel on a case-by-case basis.

#### **About This Document**

This is the P387 Draft Modification Report, which ELEXON will present to the Panel at its meeting on 13 June 2019. It includes the responses received to the Report Phase Consultation on the Panel's initial recommendations. The Panel will consider all responses, and will agree a final recommendation to the Authority on whether the change should be made.

#### <u>1</u> Summary

#### Why Change?

The current Balancing and Settlement Code (BSC) Panel Elections process is overly restrictive in terms of permissible communication methods. In regards to BSC Section H 'General' Paragraph 9.2.5, ELEXON is required to issue nomination and voting letters via post or fax which is a very time-consuming process and wastes a large amount of paper for Voting Parties and ELEXON. Voting Trading Parties are required to submit nominations and votes via post or fax which is out of date with modern technology.

#### **Solution**

The proposed solution is to amend BSC Section H 'General' Paragraph 9.2.5 to allow BSC Panel Election notices, nomination / voting papers etc. to be sent and received via email by both ELEXON and voting Trading Parties during the BSC Panel Elections period. Other forms of communication may be permissible as determined by the Panel from time to time.

#### **Impacts & Costs**

Only voting Trading Parties and ELEXON will be impacted by this Modification. This Modification will only require changes to BSC Section H, costing around £360. When the Guidance Note is written for the 2020 Panel Elections, it will need to incorporate this Change. We expect 0.25 days effort to implement the document and process changes, equating to £60.

#### **Implementation**

The Panel recommends an Implementation Date of 7 November 2019 as part of the November 2019 BSC Release, as this is the next available Release.

#### Recommendation

The Panel **unanimously agreed** an initial recommendation that P387 would better facilitate Applicable BSC Objective (d) and should therefore be **approved**. The Panel also unanimously agreed that P387 should be progressed as a **Self-Governance** Modification.

#### 2 Why Change?

#### **Background**

The BSC Panel plays an important role in helping to ensure that the provisions of the BSC are given effect. It must do so promptly, fairly, economically, efficiently, transparently and in such a manner as will promote effective competition in the generation, supply, sale and purchase of electricity. It assesses Modification Proposals against a defined set of criteria laid out in the Transmission Licence held by National Grid Electricity System Operator (NGESO), determines trading parameters and ensures that BSC Parties comply with the BSC rules.

The BSC Panel consists of:

- A Panel Chairman;
- Up to five persons (Industry Panel Members) appointed by BSC Trading Parties via an election;
- Up to two Panel Members appointed by the Citizens Advice / Citizens Advice Scotland;
- A Panel Member appointed by the National Electricity Transmission System Operator (NETSO);
- Two independent Panel Members appointed by the Panel Chairman; and
- A further Industry Panel Member (if necessary) appointed by the Panel Chairman.

With the exception of the Panel Chairman, Panel Members are appointed for a period of two years (the current Panel Members are serving a term from 1 October 2018 to 30 September 2020). It is the responsibility of ELEXON as the BSCCo to administer the election and appointment of members to the BSC Panel as stated in BSC Section B 'The Panel' Annex B-2.

The BSC Panel Election Process takes place between June and September every two years. Each BSC Trading Party / trading party group on 20 June of the year of the election may nominate one candidate to stand for election as a BSC Panel Member. Each voting Party may also submit a voting paper for each Energy Account (e.g. Production Energy Account or Consumption Energy Account) that it holds.

On 20 June in the year of the election, Trading Parties are to inform the ELEXON Election Coordinator by post or fax if any of their contacts, trading party group configurations or lead Trading Parties are incorrect for the purpose of voting. ELEXON as the BSCCo will then use this information to update the <u>Voting Share Register</u>, the list that details those who are entitled to vote.

ELEXON will then write to all eligible parties on the Voting Share Register via post or fax to seek nominations. ELEXON will then circulate via post / fax the list of candidates, their biographies and a set of voting papers to both individual Trading Parties and the lead Trading Party of each trading party group. Each voting Trading Party will cast up to three preference votes on each voting paper that they will subsequently send back to ELEXON via post or fax. Respondents may then may submit their hard-copy votes in person or via post / fax with the Election Results being announced in September.

#### What is the issue?

The most pressing issue is the time-consuming nature of the Panel Elections process which requires numerous Working Days of effort for both voting Parties and ELEXON to complete and manage effectively. The effort and time ELEXON and Trading Parties spend using post / fax is not resource efficient which could be mitigated by the use of email. The current process of requiring communication via fax or post for the panel election process could be acting as a potential barrier for participation and is unnecessary in today's age where electronic comminution is well established and trusted.

As both Trading Parties and ELEXON are obligated by the BSC to send papers and notices via post or fax, a very large amount of paper is used and unnecessary delays are caused throughout each stage of the Panel Elections process. This was seen last year where postage cost of around 800 letters was approximately £560 for both the nomination and voting stages. The paper cost on top of this was around £181.

#### **3** Solution

#### **Proposed solution**

This Modification proposes to allow the provisions relating to email in BSC Section H 9.2 to apply to the BSC Panel Elections process. This would allow all notices and papers sent during the BSC Panel Election process to be sent via email, as well as via the standard options of post or fax. A designated email address for Panel Elections already exists but all eligible Trading Parties would need to be made aware of this new email option.

Enabling email communications will benefit all Trading Parties involved in the BSC Panel Elections process due to its more efficient and cost-effective nature than bulk-posting of election materials. ELEXON will also benefit from the implementation of this Modification as the speed of communications and the receipt of nominations and votes will greatly increase. Voting Trading Parties will benefit from being able to more easily participate in the voting process (if they are not constrained to communicating with ELEXON by post or fax).

Electronic copies of all communications would automatically be saved on the ELEXON system, making the vote counting process more efficient and streamlined. This would greatly reduce the number of Working Days of effort required from ELEXON to administer the Panel Elections process.

We have also stated in the draft legal text that the BSC Panel may, at its discretion, approve the use of other forms of communication to allow for future innovation, which could further streamline the BSC Panel Elections process. At the time of writing, ELEXON's intention is to use email and there are no other plans for alternative electronic methods to be used.

## 4 Impacts & Costs

#### **Estimated central implementation costs of P382**

We will be required to implement the new legal text, but there will not be any impact on BSC Central Systems. The implementation costs to deliver the solution to this Modification Proposal, will be approximately £420, at 1.75 Working Days effort. This is inclusive of changes to BSC Section H, guidance document and process changes.

## 5 Implementation

#### **Recommended Implementation Date**

It will also ensure that both ELEXON and all parties involved in the Panel Elections process are made aware and prepared in plenty of time for the changes that this Modification entails.

#### 6 Panel's Initial Discussions

The BSC Panel agreed to raise the P387 proposal (290/05) at ELEXON's request at its meeting on 9 May 2019 in accordance with BSC Section F 'Modification Procedures' F2.1.1 (d)(i). The Panel provided their initial views on P387. The Panel unanimously agreed with all recommendations as set out in the IWA.

A Panel member queried the draft legal text, stating that it did not specifically mention the Panel Elections process when explaining that other communication methods could be used if approved by the Panel. In response to this, the draft legal text has been amended to specifically state the Panel Elections process.

#### **P387 Progression**

The Panel unanimously recommended that P387 proceed **directly to Report Phase**. This was on the basis that the P387 solution is self-evident and does not need to be assessed by a Workgroup.

#### **Self-Governance**

The Panel recommended that this Modification should be determined under Self-Governance as it does not have a material impact on any of the Self-Governance criteria listed on the previous page. This is because the P387 solution will provide efficiencies in the communication methods used for the Panel Elections process and is of a minor nature.

#### Panel's initial views against the Applicable BSC Objectives

The Panel Members provided their initial views against the Applicable BSC Objectives. The Panel **unanimously believed P387 better facilitated Applicable BSC Objective** (d) for the reasons outlined by the Proposer, which are detailed below, and should therefore be approved.

#### Applicable BSC Objective (d)

This Modification will make the Panel Elections more cost and time-efficient for voting Trading Parties and ELEXON.



# What are the Applicable BSC Objectives?

- (a) The efficient discharge by the NGESO of the obligations imposed upon it by the Transmission Licence
- (b) The efficient, economic and coordinated operation of the National Electricity Transmission System
- (c) Promoting effective competition in the generation and supply of electricity and (so far as consistent therewith) promoting such competition in the sale and purchase of electricity
- (d) Promoting efficiency in the implementation of the balancing and settlement arrangements
- (e) Compliance with the Electricity Regulation and any relevant legally binding decision of the European Commission and/or the Agency [for the Co-operation of Energy Regulators]
- (f) Implementing and administrating the arrangements for the operation of contracts for difference and arrangements that facilitate the operation of a capacity market pursuant to EMR legislation
- (g) Compliance with the Transmission Losses Principle
