10. BSC SANDBOX

10.1 BSC Derogations

Amend paragraph 10.1.1 to read as follows:

10.1.1 Subject to the provisions of paragraph 10.4.3, tThe Authority may, in accordance with this paragraph 10, grant any person, other than a BSC Company, a derogation from one or more provisions of the Code in which case paragraph 10.4 shall apply (a "**BSC Derogation**").

Amend paragraph 10.4.3(d) to read as follows:

10.4.3 In respect of each BSC Derogation:

(d) such BSC Derogation shall have no effect to the extent that it purports to derogate from:

(i) any Licence conditions;

(ii) any other Industry Code (but without prejudice to any other regulatory sandbox arrangements);

(iii) any Legal Requirement (including, for the avoidance of doubt, any Relevant European Legal Requirement - which shall include EBGL Article <u>18 terms and conditions</u>);

(iv) any provision of the Code identified in Section F1.1.9; or

(v) any provision of this paragraph 10,

and each Derogation Party acknowledges and agrees that it shall be responsible for its compliance with any such Code provision, Licence condition, Industry Code or Legal Requirement (for the purposes of this paragraph 10.4.3 a "**relevant legal requirement**");
