

APPROVAL OF BSCP602 AMENDED FOR THE APRIL 2020 STANDALONE RELEASE

Summary	BSCP602 'SVA Metering System Balancing Services Register' has been amended to give effect to two Approved Modifications in the April 2020 Standalone Release. The Panel is requested to approve the revised version of BSCP602.

1. History

- 1.1 BSCP602 'SVA Metering System Balancing Services Register' was developed for Approved Modification P344 'Implementation of Project TERRE into the GB Trading Arrangements.
- 1.2 The BSC Panel approved v1.0 of BSCP602 at a special meeting on 28 November 2018 ([Panel 284C/01](#)) for implementation on 27 February 2019.
- 1.3 As the BSC Panel was not requested to delegate the authority for BSCP602 to a Panel Committee, BSCP602 is owned by the BSC Panel.

2. April 2020 Standalone Release

- 2.1 The April 2020 Standalone Release contains two Approved Modifications:
 - [P354 'Use of ABSVD for non-BM Balancing Services at the metered \(MPAN\) level'](#); and
 - [P388 'Aligning the P344 and P354 Solutions'](#).
- 2.2 P354 amends BSCP602 to allow the National Electricity Transmission Operator (NETSO) to register Metering Systems that are not linked to a Secondary Balancing Mechanism Unit and P388 amends BSCP602 to shorten the title to 'SVA Metering System Register'.
- 2.3 Version 1.2 of BSCP602 for the April 2020 Standalone Release was issued to BSC Parties for review on 20 January via a Release Circular '[April 2020 Standalone Release – Review of changes to BSC Configurable Items](#)', with responses due by 31 January 2020.
- 2.4 We received no comments on version 1.2 of BSCP602 by 31 January 2020.
- 2.5 The BSC Panel is invited to approve v1.2 of BSCP602 for the April 2020 Standalone Release. If so approved, version 2.0 of BSCP602 will become effective on 1 April 2020.
- 2.6 All other BSC Configurable Items (CIs) amended for P354 and / or P388 will be presented to the relevant Panel Committee(s) for approval, in accordance with the BSC Baseline Statement.

3. Recommendations

- 3.1 We invite you to:
 - a) **APPROVE** version 1.2 of BSCP 602 for the April 2020 Standalone Release;
 - b) **NOTE** that version 2.0 of BSCP602 will become effective on 1 April 2020; and.
