Synopsis	This report sets out the headlines and key decisions of the most recent TDC meeting.

DECISION PAPERS

1. Trading Dispute DA1010 – (TDC261/01)

- 1.1 An error that occurred when submitting replacement Settlement data lead to erroneous energy volumes in the Post Final Settlement Run.

The TDC:

- a) **AGREED** the end date of 2 May 2017;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through Extra Settlement Determination.

2. Trading Dispute DA1037 – (TDC261/03)

- 2.1 A Supplier raised Trading Dispute DA1037 due to a metering being installed at site incorrectly. The Meter Operator Agent has attended the site and exchanged the Metering system.

The TDC:

- a) **AGREED** the end date of 10 April 2018;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

3. Trading Dispute DA1046 – (TDC261/04)

- 3.1 A Supplier raised Trading Dispute DA1046 due to erroneous Estimated Annual Consumption (EAC) data that entered Settlement. The Data Collector (DC) has corrected some of the data within Final Reconciliation (RF) from Meter memory.

The TDC:

- a) **AGREED** the end date of 10 April 2018;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the normal and Post-Final Settlement Runs.

4. Trading Dispute DA1044 – (TDC261/05)

- 4.1 An incorrect Current Transformer (CT) ratio led to incorrect Half Hourly (HH) volumes to be entered into Settlement

The TDC:

- a) **DEFERRED** the Trading Dispute.

5. Trading Dispute DA1047 – (TDC261/02)

- 5.1 A Voltage transformer (VT) Meter ratio mismatch was identified which was causing consumption to be overstated by a factor of 1.667

The TDC:

- a) **AGREED** the end date of 21 November 2018;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the post-Final Settlement Run.
