1. History

- 1.1 [Balancing and Settlement Code Procedure \(BSCP\) 201 'Black Start and Fuel Security Contingency Provisions and Claims Processes'](#) was developed for Modifications [P231 'Black Start and Fuel Security Code Procedures under the BSC'](#) and [P232 'Black Start and Fuel Security Compensation and Single Imbalance Price Derivation'](#) in 2009 to give additional detail on BSC Processes during a Black Start or Fuel Security Code Event.
- 1.2 BSCP201 is owned by the BSC Panel as the BSC Panel has not delegated responsibility.

2. May 2020 Standalone Release

- 2.1 The May 2020 Standalone Release contains amendments from the Modification [P403 'BSC Arrangements in the event that the TERRE Market is suspended by National Grid ESO'](#). This Modification was approved by the BSC Panel on 9 April 2020 as a Self-Governance Modification, with an Implementation Date of 28 May 2020.
- 2.2 P403 amends BSCP201 to clarify that the Trans-European Replacement Reserve Exchange (TERRE) Market will be suspended during a Market Suspension Period resulting from a Black Start event.
- 2.3 Version 5.3 of BSCP201 for the May 2020 Standalone Release was issued to BSC Parties for review on 23 April via a Release Circular '[May Standalone and June 2020 Release Circular: Review of BSC Configurable items](#)', with responses due by 7 May 2020.
- 2.4 We received no comments on version 5.3 of BSCP201 by 7 May 2020.
- 2.5 The BSC Panel is invited to approve v5.3 of BSCP201 for the May 2020 Standalone Release. If approved, version 6.0 of BSCP201 will become effective on 28 May 2020.

3. Recommendations

- 3.1 We invite you to:
 - a) **APPROVE** version 5.3 of BSCP201 for the May 2020 Standalone Release; and
 - b) **NOTE** that version 6.0 of BSCP201 will become effective on 28 May 2020.
