- 1.1 This update provided a summary of the recommendations made and decisions taken at PAB220 and PAB230 with regards to the Performance Assurance Framework (PAF) Review of the Supplier Charges technique.
- 1.2 The PAB:
 - a) **NOTED** the contents of the Verbal Update.
- 2. PAF Review Recommendation Breach, Default and Error & Failure Resolution (PAB235A/01)
- 2.1 This paper provided the findings and recommendations of the Performance Assurance Framework (PAF) Review in relation to the Breach, Default and Error & Failure Resolution techniques.
- 2.2 The PAB:
 - a) **APPROVED** the following recommendations outlined in the report, subject to revised wording in line with the minutes of the discussions held in the meeting:
 - Board sign off needed from Party for plan following escalation
 - Rules limiting the duration of EFR plans
 - Letter sent to a director at the outset of the EFR process
 - Streamlining customers' experience in EFR
 - Increase focus on PAB precedent register
 - Swifter consequences for repeat EFR Issues
 - Introducing new working practices for EFR escalation
 - Revising the process for the application of Breach and Default
 - Pro-active risk management to be applied prior to EFR
 - b) **DEFERRED** approval of the following recommendations outlined in the report, subject to revised wording being submitted for Approval ex-Committee in line with the minutes of the discussions held in the meeting:
 - Linking EFR to risk 'events'
