Synopsis This report sets out the headlines and key decisions of the most recent TDC meeting.

DECISION PAPERS

1. Trading Dispute DA1074– TDC276/01

- 1.1 Trading Dispute DA1074 was raised by Elexon to investigate the impact on Settlement of a disparity between measured and metered energy volumes, following the identification of a Category 1 non-compliance. Elexon considers the Trading Dispute invalid.

The TDC:

- a) **AGREED** that the materiality does not exceed £3,000;
- b) **AGREED** that a Settlement Error has not occurred;
- c) **REJECTED** the Trading Dispute; and
- d) **AGREED** that no rectification is required.

2. Trading Dispute DA1125 – TDC276/02

- 2.1 An error occurred in Settlement due to shorting links being left on a Metering System with two Meter Serial Numbers (MSNs) resulting in one of the Meters recording zero consumption.

The TDC:

- a) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- b) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- c) **AGREED** that the materiality exceeds £3,000;
- d) **AGREED** that a Settlement Error has occurred;
- e) **UPHELD** the Trading Dispute; and
- f) **AGREED** means of rectification through the Post-Final Settlement Run.

3. Trading Dispute DA1128 – TDC276/03

- 3.1 Both the Voltage Transformer (VT) ratio and Current Transformer (CT) polarity for a battery storage facility were set incorrectly, causing a Settlement Error.

The TDC:

- a) **AGREED** the end date of 24 March 2020;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

4. Trading Dispute DA1130 – TDC276/04

- 4.1 Settlement volumes for 270 tower block apartments were double-counted through the Meter for the landlord supply, causing a Settlement Error.

The TDC:

- a) **AGREED** the end date of 27 February 2020;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through the Post-Final Settlement Run.

5. Trading Dispute DA1081 – TDC276/05

- 5.1 The Supplier raised Trading Dispute DA1081 due to a blown Voltage Transformer (VT) fuse. Elexon considers Trading Dispute DA1081 to be valid against all three criteria for a valid Trading Dispute.

The TDC:

- a) **AGREED** the end date of 29 October 2019;
- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **AGREED** that the materiality exceeds £3,000;
- d) **AGREED** that a Settlement Error has occurred;
- e) **UPHELD** the Trading Dispute; and
- f) **AGREED** means of rectification through the Post-Final Settlement Run. and Extra-Settlement Determination.

6. Trading Dispute DA1027 – TDC276/06

- 6.1 The Supplier raised Trading Dispute DA1027 due to a Meter fault causing over-recording of consumption. Elexon considers Trading Dispute DA1027 to be valid against all three criteria for a valid Trading Dispute.

The TDC:

- a) **AGREED** the end date of 2 October 2018;

- b) **AGREED** that the Trading Dispute was raised in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality exceeds £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through Extra Settlement Determination.

7. Trading Dispute DA1035 – TDC276/07

- 7.1 The Supplier raised Trading Dispute DA1035 due to a Current Transformer (CT) ratio mismatch. Elexon considers Trading Dispute DA1035 to be valid against all three criteria for a valid Trading Dispute.

The TDC:

- a) **AGREED** the end date of 20 September 2018;
- b) **AGREED** that the Trading Dispute was Choose an item. in accordance with the Dispute Deadline;
- c) **DETERMINED** to exercise discretion under Section W of the Code and grant exceptional circumstances;
- d) **AGREED** that the materiality Choose an item. £3,000;
- e) **AGREED** that a Settlement Error has occurred;
- f) **UPHELD** the Trading Dispute; and
- g) **AGREED** means of rectification through Extra Settlement Determination.

INFORMATION PAPERS

8. Overview of Open Disputes - TDC276/08

- 8.1 This paper provides an overview of the Trading Disputes currently open and those awaiting rectification. Of the Trading Disputes currently open, this paper provides details of those regarded as long outstanding or presenting a significant impact on Settlement.

The TDC:

- a) **NOTED** the Trading Disputes currently awaiting rectification and open Trading Disputes; and
- b) **NOTED** the long outstanding Trading Disputes.

9. EAC AA Market and GSP Group Level SEAE - TDC276/09

- 9.1 This paper provides information to the Trading Dispute Committee (TDC) to address the issue of Erroneous Large Estimated Annual Consumptions (EACs)/Annualised Advances (AAs) in Settlement.

The TDC:

- a) **NOTED** that the current levels of error within the SEAE Graphs and further analysis do not meet the Entry criteria for a Trading Dispute; and
- b) **NOTED** the content of the paper and attachments.
