### Open Session – Decision Papers

#### 1. **MDD Change Requests for Version 325 (SVG257/01)**

- 1.1 This paper invited the SVG to approve nine General Change Requests and note 20 Fast Track Change Requests, for implementation in Version 325 of Market Domain Data (MDD) with a go-live date of 20 July 2022.
- 1.2 The SVG:
- a) **APPROVED** nine General BAU Change Requests for implementation in MDD 325 with a go-live date of 20 July 2022; and
  - b) **NOTED** 20 Fast Track Change Requests for implementation in MDD 325 with a go-live date of 20 July 2022.

#### 2. **CP1558 ‘New Registration data items to facilitate MHHS’ (SVG257/02)**

- 2.1 This document was the Change Proposal (CP) Assessment Report for CP1558 which Elexon presented to the SVG at its meeting on 5 July 2022. The Committee considered the proposed solution and the responses received to the CP Consultation before making a decision on whether to approve CP1558.
- 2.2 The SVG:
- a) **AGREED** the amendments to the proposed redlining for CP1558 made following the CP Consultation;
  - b) **APPROVED** CP1558 for implementation on 23 June 2023 as part of the standard June 2023 Release

#### 3. **New CP ‘Updating BSCP520 to address operational issues in the Central Management System’ (SVG257/03)**

- 3.1 This document provided information on a new CP and outlined our proposed progression timetable for this change, including when it will be issued for CP Consultation.
- 3.2 The SVG:
- a) **NOTED** the proposed progression timetable for the CP; and
  - b) **PROVIDED** comments or additional questions for inclusion in the CP Consultation.
  - c) **NOTED** that this CP was presented to: the SVG on 5 July 2022.

### 4. Compliance and Protocol Approvals – Prometer 100 firmware amendment and SMS and Npower protocol approvals (SVG257/04)

4.1 This paper provided the SVG with details of a compliance approval for the Prometer 100 Meter type, following a change to its firmware. It also provided the SVG with details of protocol approvals for the PRI Premier Meter type and the Landis + Gyr ZMD/ZFD Meter types, for two Half Hourly Data Collectors.

4.2 The SVG:

- a) **NOTED** that Elexon issued Secure Meters (UK) Ltd, a Meter manufacturer, with an updated Certificate of Compliance for the Prometer 100 Meter types, with the amended firmware version, in relation to Codes of Practice (CoP) 3 Issue 5, CoP5 Issue 6 and CoP10 Issue 2;
- b) **NOTED** that Elexon presented a similar information paper to the ISG, at its meeting on 5 July 2022, noting we issued Secure Meters (UK) Ltd with an updated Certificate of Compliance for the Prometer 100 Meter types, with the amended firmware version, in relation to CoP1 Issue 2, CoP2 Issue 4 and CoP3 Issue 5;
- c) **NOTED** that Elexon issued a Certificate of Protocol Approval to SMS Energy Services Ltd (UPLH), an Half Hourly Data Collector (HHDC), for the PRI Premier Meter type;
- d) **NOTED** that Elexon issued a Certificate of Protocol Approval to Npower Commercial Gas Limited (NATP), an HHDC, for the Landis + Gyr ZMD and ZFD Meter types;
- e) **NOTED** that Elexon updated the 'CoP Compliance and Protocol Approval' list for the Prometer 100 firmware amendment; the protocol approval for SMS Energy Services Ltd (UPLH); and the PRI Premier Meter type and the protocol approval for Npower Commercial Gas Limited (NATP) for the Landis + Gyr ZMD and ZFD Meter types;
- f) **NOTED** that Elexon updated the 'List of Valid Outstation Types' to include the amended firmware version for the Prometer 100 Meter types; and
- g) **NOTE** that Elexon issued a Newscast article notifying BSC Parties and BSC Party Agents about the Prometer 100 firmware amendment and the protocol approvals for the PRI Premier and Landis + Gyr ZMD and ZFD Meter types.

### 5. Compliance Approvals – New Outstation requirements due to CP1527 (SVG257/05)

5.1 This paper provided the SVG with the details of updated Certificates of Compliance issued, to reflect changes CP1527 has introduced to certain Codes of Practice.

5.2 The SVG:

- a) **NOTED** that Elexon issued Secure Meters (UK) Ltd, a Meter manufacturer, with an updated Certificate of Compliance for the Prometer 100 Meter types, against the new Issues of Codes of Practice 3, 5 and 10;
- b) **NOTED** that Elexon presented a similar information paper to the ISG, at its meeting on 5 July 2022, noting we issued Secure Meters (UK) Ltd with a Certificate of Compliance for the Prometer 100 Meter types, covering CoP1 Issue 3, CoP2 Issue 5 and CoP3 Issue 6;
- c) **NOTED** that Elexon issued EM-Lite Limited, a Meter manufacturer, with an updated Certificate of Compliance for the EMP1 Meter type, against the new Issue of Code of Practice 10; and
- d) **NOTED** that Elexon updated the 'CoP Compliance and Protocol Approval' list to include the Prometer 100 Meter types and the EMP1 Meter type as compliant with the new Issue of the relevant CoPs.

### 6. New CP 'Introducing the CVA Commissioning End to End Check' (SVG257/06)

6.1 This document provided information on a new CP and outlined the proposed progression timetable for this change, including when it would be issued for CP.
