Summary This paper presents revisions to the approved versions of Volumes 1 and 2 of

the SVA Data Catalogue for Approved Modification P344 'TERRE'. ELEXON invites the Supplier Volume Allocation Group (SVG) to approve these revisions to become effective on 28 February 2019, the P344 Implementation Date.

1. Background

- 1.1 The versions of the SVA Data Catalogue (DC) Volume 1 'Data Interfaces' and the SVA DC Volume 2 'Data Items' amended for Approved Modification P344 'Project TERRE implementation into GB market arrangements' were approved by the BSC Panel at a special meeting on 28 November 2018 (Panel 248C/01).
- 1.2 However, when updating the approved version of the SVA DC Volume 1 to change the placeholders e.g. 'Paaaa' or 'Dxxxx' - for the new Data Flows with actual Data Flow IDs, we identified that four new SVA Data Flows and related Data Items included in the approved version of BSCP508 'Supplier Volume Allocation Agent' for P344 had been omitted from the SVA DC in error.
- 1.3 The SVA DC Volumes 1 and 2 that become effective on 28 February 2019 must include all new Data Flows and Data Items introduced for P344, so we have produced new versions of these documents to supersede the approved versions for the February 2019 Release.
- 1.4 These new versions of the SVA DC Volumes 1 and 2 are presented with this paper for the SVG's approval.

2. Industry consultation on the revised changes to the SVA DC Volumes 1 and 2

- 2.1 The approved changes to the SVA DC Volumes 1 and 2 for P344 were produced as document extracts (<u>SVA Data Catalogue Volume 1 draft extract for P344 v0.1</u> and <u>SVA Data Catalogue Volume 2 draft extract for P344 v0.1</u>).
- 2.2 We created new versions of the SVA DC Volumes 1 and 2 baselined on the approved changes so that only the changes are show as redlined (<u>SVA Data Catalogue Volume 1 draft extract for P344 v0.2</u> and <u>SVA Data Catalogue Volume 2 draft extract for P344 v0.2</u>).
- 2.3 We issued the new versions of the SVA DC Volumes 1 and 2 for industry review on 15 January 2019 via a Release Circular and invited comments to be returned by 28 January 2019. We also issued a link to the Release Circular in our Newscast communication on 21 January 2019.
- 2.4 We will update the SVG verbally in the unlikely event that any material comments are received following the industry review.

2. Next steps

2.1 If the SVG approves the revised versions of the extracts to the SVA DC Volumes 1 & 2 for P344, these versions will supersede the versions previously approved by the Panel and will be incorporated to the

February 2019 versions of the full SVA DC Volumes 1 and 2 which will become effective on 28 February 2019.

3. Recommendations

 - a) **APPROVE** the revisions to the SVA DC Volumes 1 and 2, for incorporation into the versions of these documents which will become effective on 28 February 2019.
