CP1513: Background/Issue

- Inconsistencies within BSCP601, CoP3 and CoP5 due to documents not being in alignment
 - Mainly kWh/MWh inconsistencies
- Inconsistencies cause confusion to Metering Equipment manufacturers and Meter Operator Agents (MOAs)

CP1513: Solution

- Update references and clause numbers to align BSCP601, CoP3 and CoP5
 - -Change all references from 'Not applicable to CoP10' to '(CoPs 1,2,3, and 5)'
 - Delete text in tests 009 and 010 in BSCP601 as text is incorrect
 - Correct errors regarding missing references and typographical problems in BSCP601
 - -Change a reference to a clause number in CoPs 3 and 5
 - Move a sentence in CoP5 to be consistent with CoP3

CP1513 Consultation Responses

- Respondents unanimously agreed with proposed solution
