COMMITTEE RECOMMENDATIONS TO THE PANEL

1. There were no recommendations to the Panel.

OPEN SESSION – DECISION PAPERS

2. MDD Change Requests for Version 283 – SVG219/01

- 2.1 This paper invited the Supplier Volume Allocation Group (SVG) to approve nine General Change Requests, and note 15 Fast Track Change Requests, for implementation in Version 283 of Market Domain Data (MDD) with a go-live date of 22 May 2019.
- 2.2 The SVG:
 - a) **APPROVED** the nine General Change Requests for implementation in MDD 283 with a go-live date of 22 May 2019;
 - b) **NOTED** the 15 Fast Track Change Requests for implementation in MDD 283 with a go-live date of 22 May 2019; and
 - c) **APPROVED** the proposed Line Loss Factor Classes (LLFCs) for four Distributors for use in Settlement from 22 May 2019.

3. Approval of the document changes for P367 as part of the June 2019 BSC Release – SVG219/02

- 3.1 This paper invited the SVG to approve changes to various Code Subsidiary Documents following the approval of Modification P367 as part of the June 2019 BSC Release.
- 3.2 The SVG:
 - a) **APPROVED** the changes to the documents listed as for SVG approval in table 1 for the June 2019 BSC Release.

4. Valid combination updates to the operational information document – SVG219/03

- 4.1 The Unmetered Supplies User Group (UMSUG) has recommended changes to the Valid Combination Tables defined in the Operational Information Document (OID). ELEXON invited the SVG to agree these changes as Version 19.0 of the OID for use and publication on the ELEXON website.
- 4.2 The SVG:
 - a) **APPROVED** the changes to the OID; and

5. Approval of the Swarco Measured Central Management Systems – SVG219/04

5.1 ELEXON has conducted witness testing of the Swarco measured Central Management System (mCMS). The system met all BSC requirements. ELEXON invited the SVG to approve the mCMS for use in Settlement.

5.2 The SVG:

a) **NOTED** that the Swarco mCMS has passed ELEXON's witness testing against the requirements specified in BSCP520;

b) **APPROVED** the Swarco mCMS (Version 1.0) for use in Settlement; and
