Change Proposal – BSCP40/02	CP No: CP1518 <i>Version No: 1.0</i> <i>(mandatory by BSCCo)</i>
Title (mandatory by originator) 'Housekeeping change to address errors in the approved changes to BSCP514 for CP1515'	
Description of Problem/Issue (mandatory by originator) CP1515 'Meter Operator Agents to send Metering System Data to SMRS instead of ECOES for the Faster Switching Programme' was approved by the SVG on 2 April 2019 for implementation on 27 June 2019, as part of the June 2019 BSC Release. After approval of CP1515 there were six instances of the same minor error identified in the BSCP514 redlining. The approved redlined changes to BSCP514 contain the incorrect name for the D0312 Data Flow in six process steps. The cause of the issue is: <ul style="list-style-type: none"> • The amended title of the D0312 data flow under DTC CP3554 'Update of Meter Details to MPAS' is "D0312 Notification of Meter Information to MPAS", where "MPAS (Metering Point Administration Service)" is a Master Registration Agreement ("MRA") term, as the D0312 is defined in the MRA Data Transfer Catalogue ("DTC"); • The BSC uses a different term "Supplier Metering Registration Service (SMRS)", which is equivalent to MPAS; • As a result, many steps in BSCP514 should have "SMRS" as the recipient of the D0312 "Notification of Meter Information to MPAS"; • In six cases, the title of the D0312 was erroneously amended to "Notification of Meter Information to SMRS" in error. <p>The first reference to the D0312 in BSCP514 Section 2.1.4.1, the title has been deleted in error, rather than amended, and D0312 is in brackets, which is incorrect.</p> <p>In step 5.4.1.15, the following were not shown as redlined:</p> <ul style="list-style-type: none"> • the change from "ECOES" to "SMRS" in the "To" column; and • the change from "D0312 Notification of Meter Information to ECOES" to "D0312 Notification of Meter Information to MPAS" in the "Information Required" column. <p>In 5.4.1.16 the word 'to' was left out of:</p> <p>'D0312 Notification of Meter Information to MPAS with 'MOP Flow Response Code' populated.'</p>	

Proposed Solution (mandatory by originator)

Amend the following sections of BSCP514 to change the incorrect D0312 title, ‘Notification of Meter information to SMRS’ to the correct D0312 title ‘Notification of Meter information to MPAS’:

- Section 5.2.2.20
- Section 5.3.5.7
- Section 6.3.3.8
- Section 6.3.4.6
- Section 6.3.4.24
- Section 6.3.5.6

Amend Section 2.1.4.1 as follows:

“This will be done by sending a (D0312 ‘Notification of Meter information to MPAS’) flow...”

Show that ECOES was deleted and replaced with SMRS (in the “To” column) and with MPAS (in the name of the D0312 in the “Information Required” column) in 5.4.1.15.

Add the word ‘to’ to the “Information Required” column 5.4.1.16.

Justification for Change (mandatory by originator)

The current redlining could cause confusion to Market Participants, as the title of D0312 is incorrect, therefore, implementing this CP will provide clarity in the BSC arrangements.

As this CP contains only minor typographical errors of an inconsequential nature, it should be treated as a Housekeeping CP under Balancing and Settlement Code Procedure (BSCP) 40 ‘change Management’ provisions.
