

<b>Change Proposal – BSCP40/02</b>	<b>CP No: CP1521</b> <i>Version No: v1.0</i>
<b>Title</b> BSCP70 Amendments for Interconnector Administrator and Interconnector Error Administrator	
<b>Description of Problem/Issue</b> BSCP70 omits Interconnector Administrator (IA) and Interconnector Error Administrator (IEA) from being required to undergo CVA Qualification Testing. As there are four new Interconnectors are scheduled to go live over the next four years (with a further seven planned) there is a potential risk to Settlement if the IAs and IEAs for the new Interconnectors have not demonstrated that they are able to send and receive the relevant Settlement data flows to/from BSC Central Systems.	
<b>Proposed Solution</b> As the IA and IEA roles under the BSC require communication with BSC Central Systems. BSCP70 should be amended to remove the statement which excludes IAs and IEAs from the requirement to undergo CVA Qualification Testing. BSCP70 should also be amended to include the data flows relevant to IEAs and IAs for CVA Qualification Testing.	
<b>Justification for Change</b> This CP will make the CVA qualification process explicit to IAs and IAEs and reduce risk to Settlement as a result. This removes the inconsistency between BSCP70 and Section O and thus the Communications Requirement Document (CRD) which lists the IA/IEA flows for CVA qualification.	
<b>To which section of the Code does the CP relate, and does the CP facilitate the current provisions of the Code?</b> <a href="#">Section O ‘Communications Under the Code’</a> . The CP facilitates Section O provisions by defining the interfaces, interdependencies and timetable for the CVA Qualification Testing for IAs and IEAs in BSCP70.	
<b>Estimated Implementation Costs</b> The central implementation costs for implementing this CP is estimated at £3,691.
