## 2. MDD Change Requests for Version 289 – SVG224/01

- 2.1 This paper invited the SVG to approve two General Change Requests, and note nine Fast Track Change Requests, for implementation in Version 289 of Market Domain Data (MDD) with a go-live date of 23 October 2019.
- 2.2 The SVG:
  - a) APPROVED the two General Change Requests for implementation in MDD 289 with a go-live date of 23 October 2019; and
  - b) **NOTED** the nine Fast Track Change Requests for implementation in MDD 289 with a go-live date of 23 October 2019.

## 3. Approval of Document changes for CP1517 – SVG224/02

- 3.1 This paper invited the SVG to approve changes to the various Balancing and Statement Code (BSC) Category 2 Configurable Items (CIs) amended for approved Change Proposal CP1517 as part of the Wider Access and TERRE Standalone Release.
- 3.2 The SVG:
  - a) **APPROVED** the changes to the SVG-owned Category 2 BSC CIs amended for CP1517 as part of the Wider Access and TERRE Standalone Release; and
  - b) **NOTED** that the implementation date for these changes will be the date specified in the National Electricity System Operator (NETSO) P344 TERRE Final Implementation Notice.

#### 4. UMSUG updates to the Operational Information Document – SVG224/03

- 4.1 The Unmetered Supplies User Group (UMSUG) recommended a number of changes to the Operational Information Document (OID).
- 4.2 The SVG:
  - a) **NOTED** the changes to the OID recommended by the UMSUG;

- b) **APPROVED** the changes to the OID; and
- c) **NOTED** that, subject to approval, the updated OID will be published on the BSC Website when MDD change go-live in October.

# 5. CP1519 'Treatment of Low Capacity Connections for Site Specific Line Loss Factor Calculations' – SVG224/04

- 5.1 CP1519 proposes to amend Principle 17 in <u>BSCP128</u>, and three of its appendixes to reflect the changes, so that Licensed Distribution System Operators (LDSOs) can use a generic Line Loss Factor (LLF) for subordinate connections as a default replacement process as permitted by Principle 17. The SVG was invited to consider the proposed solution and the responses received to the CP Consultation in order to make a decision on whether to approve CP1519.
- 5.2 The SVG:
  - a) **AGREED** the amendments to the proposed redlining to BSCP128 made following CP Consultation;
  - b) **APPROVED** the proposed changes to BSCP128, BSCP128 Appendix One, BSCP128 Appendix Three and BSCP128 Appendix Ten for CP1519;
  - APPROVED CP1519 for implementation on 27 February 2020 as part of the February 2020 BSC Release; and
  - d) **NOTED** that the ISG approved CP1519 for implementation on 27 February 2020 at its meeting on 17 September 2019.
