Summary **We invite the SVG to note the proposed SVG meeting dates for 2022.**

1. Background

1.1 The Balancing and Settlement Code (BSC) Panel has agreed the 2022 Panel Meeting dates. These are scheduled to occur on the second Thursday of every calendar month. The Panel Committee meeting dates follow the same set timetable each year which the SVG ties in to.

2. Proposed Meeting Dates

2.1 There has been no change to the current approach for SVG meetings and these are scheduled for the first Tuesday of each month. The only exception to this is in January 2022 when we propose to hold the SVG meeting on the second Tuesday of the month to allow for an efficient turnover after the Christmas break.
