Synopsis **This report sets out the headlines and key decisions of the most recent SVG meeting.**

OPEN SESSION – DECISION PAPER

1. **MDD Change Requests for Versions 320- (SVG252/01)**

1.1 This paper invited the SVG to approve four General Change Request and note six Fast Track Change Requests, for implementation in Version 320 of Market Domain Data (MDD) with a go-live date of 16 February 2022.

The SVG:

- a) **APPROVED** four General BAU Change Request for implementation in MDD 320 with a go-live date of 16 February 2022; and
- b) **NOTED** six Fast Track Change Requests for implementation in MDD 320 with a go-live date of 16 February 2022.

2. **CP1556 ‘Adding P-flows and a testing request process to the VLP and AMVLP Market Entry’- (SVG252/02)**

2.1 This document was the Change Proposal (CP) Assessment Report for CP1556 which Elexon presented to the ISG at its meeting on 1 February 2022 and the SVG at its meeting on 1 February 2022. The Committees considered the proposed solution and the responses received to the CP Consultation before making a decision on whether they would approve CP1556.

The SVG:

- a) **APPROVED** the proposed changes to BSCP70 and the Communication Requirements Document; and
- b) **APPROVED** CP1556 for implementation on 30 June 2022 as part of the standard June 2022 BSC Release.

3. **CP1555 ‘Consumption data for Measurement Classes G and F’- (SVG252/04)**

3.1 This document is the Change Proposal (CP) Assessment Report for CP1555 which Elexon presented to the SVG at its meeting on 1 February 2022. The Committee considered the proposed solution and the responses received to the CP Consultation before making a decision on whether to reject CP1555.

The SVG:

- a) **REJECTED** the proposed changes to BSCP502, the SVA Data Catalogue, and EMAR for CP1555;
- b) **REJECTED** CP1555.

4. Profile Expert Group Recommendations- (SVG252/03)

4.1 The PEG recommended that the TPDs from Set 1 be used in Settlement from 1 April 2022. The PEG also recommended that certain AFYCs and Default EACs are updated in Market Domain Data (MDD) for use in Settlement from 1 April 2022.

The SVG:

- a) **APPROVED** the TPDs for use in Settlement from 1 April 2022;
- b) **APPROVED** 112 GGPCDEACs, 600 GGPCAEACs and their corresponding sets of AFYCs are updated with effect from 1 April 2022;
- c) **APPROVED** the new set of HH Default EACs for Measurement Classes C and D;
- d) **NOTED** that Elexon will raise the necessary Change Requests to update all data items in MDD; and
- e) **NOTED** that the SVAA systems will be updated with the new TPDs.
