Summary **Elxon has reviewed the Terms of Reference (ToR) for the SVG BSC Panel sub-committee. This paper presents the proposed changes to the SVG ToR.**

---

### 1. Background

- 1.1 The four BSC Panel sub-committees<sup>1</sup> have approved Terms of Reference documents, which govern the remit of each Committee and set out the procedures for how they should operate.
- 1.2 These Terms of Reference should be reviewed on a regular basis, with any changes being endorsed by the relevant Committee before being presented to the BSC Panel for approval.

### 2. Key changes

#### Adjustment to Membership appointment rules

- 2.1 It is proposed to amend the appointment of SVG Industry Members to be by all Members of the Panel and not just the Industry Members.
- 2.2 It is proposed to add a representative from the Retail Energy Code Company (RECCo) to the SVG, reflecting the fact that Elxon sit on a number of RECCo Committees.

### 3. Minor changes

- 3.1 The reference to MRASCo has been removed in 5.3.1.
- 3.2 A typo has been corrected in 5.3.6.

### 4. Next steps

- 4.1 The SVG is invited to review and discuss the proposed updated ToR (Attachment A), and provide comments on the key changes outlined above.
- 4.2 Any additional changes or suggestions from Committee Members are welcomed at this stage.
- 4.3 If the SVG endorses the proposed changes (in whole or in part), they will be presented to the BSC Panel at its 10 March 2022 meeting, along with the three other sub-committees' ToR for approval.
- 4.4 If approved by the BSC Panel, the revised ToR will be effective immediately (and therefore be effective from the April 2022 SVG meeting), unless determined otherwise by the BSC Panel.
