Synopsis This report sets out the headlines and key decisions of the SVG meeting.

Open Session – Decision Papers

1. MDD Change Requests for Version 324-(SVG256/01)

- 1.1 This paper invited the SVG to approve three General Change Requests and note 15 Fast Track Change Requests, for implementation in Version 324 of Market Domain Data (MDD) with a go-live date of 22 June 2022.
- 1.2 The SVG:
 - a) **APPROVED** three General BAU Change Requests for implementation in MDD 324 with a go-live date of 22 June 2022; and
 - b) **NOTED** 15 Fast Track Change Requests for implementation in MDD 324 with a go-live date of 22 June 2022.

2. Metering Dispensation D/544 CP1553-(SVG256/02)

- 2.1 Elexon has applied for a Temporary Metering Dispensation (D/544) to grant a derogation from the new requirements to be implemented via CP1553 from June 2022. The application was gives affected parties time to use up existing stock of Class 2 Meters and class 0.5 CTs.
- 2.2 The SVG:
 - a) **APPROVED** Metering Dispensation D/544 against Codes of Practice 3, 5 and 10 on a temporary basis of 18 months from the implementation date of CP1553 (June 2022), as a generic Metering Dispensation.
 - b) NOTED that Elexon will present a similar paper to the ISG, with a similar recommendation, in respect of CoP
 3.

3. Approval of Configurable Item changes for the June 2022 BSC Release (SVG256/03)

- 3.1 This paper invited the SVG to approve the changes to BSC Configurable Items as part of the June 2022 BSC Release.
- 3.2 The SVG:
 - a) **APPROVED** the amendments to the document listed in Table 1, as detailed in Attachment A, to be implemented on 30 June 2022 as part of the June 2022 BSC Release.

4. CP1563 'Altering the Trigger Point for CT Commissioning'-(SVG256/Verbal)

- 4.1 Following discussions with the Proposer, Elexon believed was appropriate to redraft the CP proposal form to provide clarity on the impact to overall commissioning timescales, therefore it was recommend that CP1563 be issued for a second CP Consultation, including the revised red line text and updated justification for the solution, subject to SVG approval. The revised red line text is consistent with the proposed text to be included in the REC Metering Operations Schedule
- 4.2 The SVG:
 - a) AGREED the amendments to the justification and redlining for BSCP515 for CP1563; and
 - b) AGREED that CP1563 be sent for a second Industry Consultation; and
 - c) NOTED the proposed progression timetable for CP1563.

5. CP1554 'Future proofing the measurement transformer standards-(SVG256/05)

- 5.1 CP1554 was approved for implementation in June 2022 by the SVG at its January 2022 meeting. This paper invited the SVG to approve the industry agreed Code of Practice (CoP) 2 redline text to compliment the CP1554 solution.
- 5.2 The SVG:
 - a) NOTED that no changes have been made to CoPs 3, 4, 5 and 10 for CP1554;
 - b) NOTED that CP1554 is planned for implementation on 30 June 2022; and
 - c) **NOTED** that CoP2 will be presented for approval to the ISG on 7 June 2022.
