Open Session – Decision Papers

1. **MDD Change Requests and Technical Product Deliverables for Version 326 (SVG258/01)**

- 1.1 This paper invited the SVG to approve five General Change Requests and note 14 Fast Track Change Requests, for implementation in Version 326 of Market Domain Data (MDD) with a go-live date of 17 August 2022. The SVG was also invited to approve the Technical Product Deliverables (TPDs) Autumn/Winter 2022/23 BSC Seasons.
- 1.2 The SVG:
- APPROVED** four General BAU Change Requests for implementation in MDD 326 with a go-live date of 17 August 2022;
 - APPROVED** the TPDs for use in Settlement for the remainder of the current BSC Year; and
 - NOTED** 14 Fast Track Change Requests for implementation in MDD 326 with a go-live date of 17 August 2022.

2. **Approval of Configurable Item changes for the February 2023 Release (SVG258/05)**

- 2.1 This paper invited the SVG to approve the changes to BSC Configurable Items as part of the February 2023 Release.
- 2.2 The SVG:

3. CP1563 ‘Altering the Trigger Point and subsequent Timescales for Commissioning SVA CT Operated Metering Systems and issue of Data Flow’ Assessment Report (SVG258/02)

3.1 Elexon presented the Change Proposal (CP) Assessment Report for CP1563. The Committee considered the proposed solution and the responses received to the CP Consultation before making a decision on whether to approve CP1563.

3.2 The SVG:

a) **NOTED** CP1563 has been recommended for approval and implementation on 3 November 2022 as part of the Standard November 2022 BSC Release.

4. Protocol Approval – Callisto (MDSL) for the Elster AS230, A1140 and A1700 Meter types (SVG258/03)

4.1 We invited the SVG to note that, following successful protocol testing, Callisto Data Limited (Callisto) has been issued with a Certificate of Protocol Approval. The certificate covers approval of the protocols for the Elster AS230, A1140 and A1700 Meter types, embedded within Callisto’s Connexo data collection software.

4.2 The SVG:

a) **NOTED** that Elexon issued a Certificate of Protocol Approval to Callisto Data Limited (MDSL), an Half Hourly Data Collector (HHDC), for the Elster AS230, A1140 and A1700 Meter types;

b) **NOTED** that Elexon updated the ‘CoP Compliance and Protocol Approval’ list for the protocol approval for the Elster AS230, A1140 and A1700 Meter types, using Callisto Data Limited (MDSL) as an HHDC; and

c) **NOTED** that Elexon issued a Newscast article notifying BSC Parties and BSC Party Agents about the protocol approval for the Elster AS230, A1140 and A1700 Meter types, using Callisto Data Limited (MDSL) as an HHDC.
