<b>Change Proposal – BSCP40/02</b>	<b>CP No:</b> <i>Version No: 1.0</i> <i>(mandatory by BSCCo)</i>
<b>Title (mandatory by originator)</b> Housekeeping amendments to BSCP65 and BSCP70 to include reference to ‘Asset Metering Virtual Lead Party’	
<b>Description of Problem/Issue (mandatory by originator)</b> <p>When we developed the suite of amendments to Balancing and Settlement Code (BSC) Configurable Items (CIs) to deliver the solution to Approved Modification <a href="#">P375 'Settlement of Secondary Balancing Mechanism (BM) Units using metering behind the site Boundary Point'</a> as part of the June 2022 BSC Release, we did not include <a href="#">Balancing and Settlement Code Procedure (BSCP) 65 'Registration of Parties and Exit Procedures'</a> or <a href="#">BSCP70 'Central Volume Allocation (CVA) Qualification Testing for Parties and Party Agents'</a>.</p> <p>BSCP65 and BSCP70 currently include references to ‘Virtual Lead Party’ and ‘VLP’ and BSCP70 includes the definition of AMVLP, but neither document otherwise refers to ‘Asset Metering Virtual Lead Party’ or ‘AMVLP’; these documents should have been amended to include references to ‘Asset Metering Virtual Lead Party’ and ‘AMVLP’ alongside references to ‘Virtual Lead Party’ and ‘VLP’ for P375.</p> <p>As BSCP65 and BSCP70 are referenced in <a href="#">BSCP537 'Qualification Process for Supplier Volume Allocation (SVA) Parties, SVA Party Agents, Virtual Lead Parties (VLPs), Asset Metering Virtual Lead Parties (AMVLPs), AMVLP Agents and CVA Meter Operator Agents (MOAs)'</a> in the initial stage of the Qualification application, we believe that it would be beneficial to amend BSCP65 and BSCP70 to clarify that AMVLPs are also subject to the obligations set out in BSCP65 and BSCP70.</p>	
<b>Proposed Solution (mandatory by originator)</b> <p>Add ‘Asset Metering Virtual Lead Party’ and ‘AMVLP’, as appropriate, to BSCP65 and BSCP70.</p> <p>This change will clarify obligations on applicants wishing to become an Asset Metering Virtual Lead Party.</p> <p>We believe that this Change Proposal should be progressed as a Housekeeping change for implementation in the November 2022 BSC Release. The Change Proposal is seeking to correct a minor error in the omission of references to ‘Asset Metering Virtual Lead Party’ or ‘AMVLP’, which were within the original intent of Modification P375.</p>	
<b>Justification for Change (mandatory by originator)</b> <p>To ensure that ‘Asset Metering Virtual Lead Party’ or, where applicable, ‘AMVLP’ is included in the BSC Processes for Registration and Market Exit set out in BSCP65 and are subject to CVA Qualification under BSCP70, as other Trading Parties are.</p>
