- 4. Housekeeping amendments to BSCP65 and BSCP70 to include reference to 'Asset Metering Virtual Lead Party' (SVG259/03)
- 4.1 This paper invited the SVG to approve a new CP. The committee considered the proposed solution and was asked to approve the changes to BSCP65 and BSCP70 outlined in this paper.
- 4.2 The SVG:
 - a) AGREED that this CP is a Housekeeping CP as defined in BSCP40;
 - b) **APPROVED** the proposed changes to BSCP65 and BSCP70 for this CP;
 - c) **APPROVED** the CP for the implementation on 3 November 2022 as part of the standard November 2022 Release; and
 - d) NOTED that this CP will be also presented for decision to the ISG on 6 September 2022.

5. LLF Methodology Audit Report (SVG259/05)

- 5.1 This paper provided a summary of Elexon's review of the Line Loss Factor (LLF) methodology statements submitted by Licensed Distribution System Operators (LDSOs), in accordance with BSCP128 and sought the SVG's approval of those methodologies.
- 5.2 The SVG:

 - b) NOTED that all Embedded LDSOs intend to Mirror Host LDSO Generic LLFs; and
 - c) **NOTED** that the LDSO methodologies will be presented to the ISG for approval at its 6 September 2022 meeting.
- 6. CP1565 'Updating BSCP520 to address operational issues in the Central Management System' (SVG259/08)
- This paper invited the SVG to approve the CP Assessment Report for. The Committee considered the proposed solution and the responses received to the CP Consultation before making a decision on whether to approve CP1565.

 - a) AGREED the amendments to the proposed redlining for BSCP520 for CP1565 made following the CP Consultation:
