Part I: Public session – Decision Papers

1. MDD Change Request Version 331 (SVG263/01)

- 1.1 This paper invited the SVG to approve six General Change Requests and note four Fast Track Change Requests, for implementation in Version 331 of Market Domain Data (MDD) with a go-live date of 25 January 2023.
- 1.2 The SVG had no comments.
- 1.3 The SVG:
 - a) **APPROVED** six General BAU Change Requests for implementation in MDD 331 with a go-live date of 25 January 2023; and
 - b) **NOTED** four Fast Track Change Requests for implementation in MDD 331 with a go-live date of 25 January 2023.

2. CP1573 'Amendments to the approved NETA Interface Design Document Spreadsheet and SVA Data Catalogue Volume 2 for P376' (SVG263/02)

- 2.1 Elexon invited the SVG to approve amendments to configurable items as part of the implementation of P376.
- 2.2 The SVG had no comments.
- 2.3 The SVG:
 - a) **APPROVED** the proposed changes to the IDD Part 1 Spreadsheet, SVA Data Catalogue Volume 2 and D0393 Market Message for CP1573;
 - b) **APPROVED** CP1573 for implementation on 23 February 2023, as part of the standard February 2023 Release; and
 - c) **NOTED** that CP1573 will also be presented for decision to the ISG on 10 January 2023.

3. CP1571 Assessment Report (SVG263/03)

- 3.1 Elexon invited the SVG to approve the proposed changes for CP1571 Assessment Report.
- 3.2 An SVG Member queried how Elexon is aware that all other parties and meter operators are compliant when getting only one consultation response, Elexon stated that checks are done within the Performance Assurance Framework to ensure compliance against any new obligations.
- 3.3 The SVG:
 - a) **APPROVED** the proposed changes to CoP3 and CoP5 for CP1571;
 - b) **APPROVED** CP1571 for implementation on 29 June 2023 as part of the standard June 2023 Release; and
 - c) **NOTED** that CP1571 will also be presented for decision to the ISG on 10 January 2023

4. CP1572 Assessment Report (SVG263/04)

- 4.1 Elexon invited the SVG to approve a requirement to the relevant CoPs that mandates that an SLD must be created, and be auditable, for new HV and EHV Metering Systems, or reconfiguration of HV and EHV sites with a go live date in June 2023.
- 4.2 An SVG Member shared concern about if a party is unsure on the instructions that are provided do they get any guidance. Elexon confirmed that once the redlining has been submitted and approved, the new redlining would provide sufficient clarity; if parties need extra support they can get in touch with Elexon for further assistance.
- 4.3 The SVG:

- a) **AGREED** the amendments to the proposed redlining for CoP3, CoP4 and CoP5 for CP1572 made following the CP Consultation;
- b) **APPROVED** the proposed changes to CoP3, CoP4 and CoP5 for CP1572;
- c) **APPROVED** CP1572 for implementation on 29 June 2023 as part of the standard June 2023 Release; and
- d) **NOTED** that CP1572 will also be presented for decision to the ISG on 10 January 2023.

5. Updates to UMSUG Terms of Reference (SVG263/05)

- 5.1 This paper invited the SVG to approve updates to the Unmetered Supplies User Group's (UMSUG's) Terms of Reference.
- 5.2 The SVG had no comments.
