Part I: Open session – Decision Papers

1. MDD Change Request Version 333 (SVG265/01)

- 1.1 This paper invited the SVG to approve seven General Change Requests and note 13 Fast Track Change Requests, for implementation in Version 333 of Market Domain Data (MDD) with a go-live date of 22 March 2023.
- 1.2 The SVG Committee had no comments.
- 1.3 The SVG:
 - a) **APPROVED** seven General BAU Change Requests for implementation in MDD 333 with a go-live date of 22 March 2023; and
 - b) **NOTED** 13 Fast Track Change Requests for implementation in MDD 333 with a go-live date of 22 March 2023.

2. LLF Audit Results 2023-2024 (SVG265/02)

- 2.1 This paper reported the results of Elexon's annual audit of Line Loss Factor (LLF) values for the 2023/2024 BSC Year, performed in accordance with BSCP128.
- 2.2 The SVG Committee had no comments.
- 2.3 The SVG:
 - a) **NOTED** that all SVA non-compliances have been resolved;
 - b) **APPROVED** the SVA LLFs for use in Settlement from 1 April 2023 to 31 March 2024; and
 - c) **NOTED** that Elexon will seek the ISG's approval of the CVA LLFs at its meeting on 7 March 2023.

3. Metering Dispensation D/534 - Update for CoP5 Issue 7 (SVG265/03)

- 3.1 We invited the SVG to agree that Metering Dispensation D/534 should be updated to cover registrations of this DC metering solution against CoP5 Issue 7 from 30 June 2022.
- 3.2 The SVG Committee had no comments.
- 3.3 The SVG:
 - a) **APPROVED** an update to Metering Dispensation D/534 to cover CoP5 Issue 7;
 - b) **NOTED** that Elexon will update the Statement of Generic Metering Dispensations for D/534 to make it clear that D/534 can be used against CoP5 Issue 6 and CoP5 Issue 7; and
 - c) **NOTED** that Elexon will provide a verbal update to the ISG at its meeting, on 7 March (ISG263), in relation to the SVG's decision about the update of D/534 for CoP5 Issue 7.

Part II: Open session – Information Papers

4. Compliance Approvals – CP1527(SVG265/04)

- 4.1 This paper invited the SVG to note that EDMI Europe Limited (EDMI), Landis+Gyr Ltd (L+G) and Em-Lite Limited (Em-Lite) have confirmed that their integral Outstation Meter types comply with the new Issues of CoPs 3, 5 and 10, where applicable.
- 4.2 A SVG Member asked if this was all of the manufacturers' Meter types in their suites, or if they were only specific ones. Elexon confirmed that for the majority of the manufacturers, it was all of their Meter types on the CoP Compliance and Protocol Approval list. For one manufacturer (L+G), there was a Meter type with an older firmware version (B24) that they no longer produce, which the manufacturer didn't apply for approval for.

4.3 The SVG:

- a) **NOTED** that Elexon had issued EDM1, L+G and Em-Lite, Meter manufacturers, with updated Certificates of Compliance for their integral Outstation Meter types, against the new Issues of Code of Practice (CoPs) 3, 5 and 10, where applicable;
- b) **NOTED** that Elexon had updated the 'CoP Compliance and Protocol Approval' list to include the EDM1, L+G and Em-Lite integral Outstation Meter types as compliant with the new Issues of CoPs 3, 5 and 10, where applicable and issued Newscast articles; and
- c) **NOTED** that Elexon will presented a similar information paper to the ISG, at its meeting on 7 March 2023, in relation to Elexon issuing EDM1 and L+G Certificates of Compliance for their integral Outstation Meter types, against CoP1 Issue 3, CoP2 Issue 5 and CoP3 Issue 6, where applicable.
